## **County Council talks public engagement policies** Coffee with a Councillor program and annual open houses discussed

At their December 17 GPC meeting, Yellowhead County Council addressed their public engagement policies, specifically policies 1100.24 Coffee with a Councillor and 1100.15 Public Engagement & Communication.

After Council discussion on public engagement at their last GPC meeting, Administration reviewed policy 1100.15 with the intention of incorporating holding public open houses annually, in addition to providing Councillors the opportunity to schedule local meetings to engage their electoral division residents.

Council was presented with revised policy 1100.15, which included the addition of section 1.6 to "Hold public open houses annually, with both Council and Administration in attendance, to provide public review and input opportunities."

The principle also notes that the open houses will be held three times yearly, in a three-year cycle to cover the West, East, and Central portions of Yellowhead County. Open houses will not be held in a general election year, to avoid unfair access to voters between candidates that aren't on Council and candidates that are.

Section 1.7 was also added, which states, "Provide each Councillor a chance to informally discuss ideas or concerns regarding municipal programs and services with residents in their electoral division through a 'Coffee with a Councillor' program."

The incorporation of these sections "allows all of Council to engage with residents throughout the County annually, well ensuring that every area has the opportunity to engage with all of Council numerous times a year in a four-year Council term," said CAO Luc Mercier. "The open houses would provide residents additional opportunities to become informed of various projects and meet and interact with all members of Council and administration while allowing them to ask questions and raise any concerns they have to the whole of Council."

To further detail the addition of section 1.7 in policy 1100.15, policy 1100.24 Coffee with a Councillor was also presented to Council. "The intent of this policy is to create another avenue for residents to meet with their local Councillor," said CAO Mercier. "It allows individual Councillors to schedule local meetings to engage local residents in a more relaxed, informal setting."

At their discretion, Councillors will be able to expense a maximum of \$300 twice per year to pay for a portion of Hall rentals and incidentals, to allow

the Coffee with a Councillor meetings to occur.

Because these meetings are at the discretion of individual Councillors, the proposed policy also restricts municipal Administration from being involved, and does not allow meetings to take place within eight months of a general election.

Mercier recommended to Council that they bring both policies to a future Council meeting for consideration.

Councillor Dawn Mitchell expressed concerns over "Councillors meeting by themselves with residents". "There's quite a bit of danger for misinformation to be spread out there," she said. "I would appreciate [the draft bylaw] to read something like, 'Councillors holding a meeting need to notify the rest of Council so that we have the opportunity to attend and support our team mates.""

"When we run, we run individually in divisions, but once we are elected we stand together and these are perfect opportunities for perhaps myself on the West end to understand firsthand what's going on in the East end," Mitchell continued. "I would hate to be excluded from that."

Councillor Brigitte Lemieux agreed with the possibility of a Councillor "inadvertently providing misinformation," and said that she would only support the policy if it included a section about inviting other members of Council to attend.


Councillor Anthony Giezen spoke as an "advocate" of the Coffee with a Councillor policy, stating that members of Council often want to speak to their residents before "finalizing their decision-making process."

Giezen pointed out that this practice may unintentionally exclude residents that are not "on [a Councillor's] radar." "I think Coffee with a Councillor is an easy way for somebody who may not be in the immediate circle to come out and express something quite simple in an informal basis," he said.

Mitchell requested that the policy specify that a Councillor give other members of Council 30 days notice before an event. She also requested that advertising of the Coffee with a Councillor events be shared on the County's social media and website, so that residents can be made aware.

The robust discussion brought forth a few amendments to the policy: that the allowance of Coffee with a Councillor meetings be changed from the eight month time frame to "during the election year," that Councillors inform other members of Council two weeks ahead of a meeting, and that the meetings be advertised on social media and the website at least two weeks prior.

With the changes, Council voted unanimously to bring the policies to a future Council meeting for consideration.

Finally, they did a "Gallery Walk" to analyze each other's ads to see their persuasiveness. Other PGMS students and staff were also invited to check out their projects and share their feedback on how persuasive, or not, their projects were using an analysis handout.

## **Peers Community Youth Group performs 'The Christmas Visitor'**

The Peers Community Youth Group held an event before Christmas for the whole community at the Carrot Creek Christian Fellowship Church in Peers.

The event was a dramatic performance called 'The Christmas Visitor'. The play started at 6:30pm and was a fundraiser for the two community groups and other local organizations.

The group has been putting on a performance like this for the past six years. This year's play was an adaptation of Leo Tolstoy's 'Where love is, there God is also.' The plot centered around a shoemaker turned cell-phone repairman, Martin, and his experiences helping others during the Christmas season. The play was approximately an hour long with one intermission.

The production came together successfully in a very short time. "We like to start in October, but with all the extracurricular school activities, getting teenagers to commit the time is tough. It usually isn't until November that we get scripts in hand and start casting. This year casting happened the first week of November," said Sean Gurnsey, youth pastor and play director, "All said, tonight was awesome. We have quite a few thespians in our midst. It's so much fun. They're a good crew to do it with."

The group has four different plays that they rotate every year. "All of the stories we pick are stuff that we've kind of adapted from our own experience," said Gurnsey.

The event also included a silent auction as part of the fundraising. "Its free to come, there's no entry price, and people don't have to donate. But a lot of people still put something in the donation box," explained Gurnsey. All proceed were shared between the Peers Youth Group, the Yellowhead Pregnancy Care Centre, and meals for the homeless though Shekinah Coffee. During the intermission attendees could bid on various items, or enjoy free snacks and coffee.

"Yes we want to raise funds for our youth group, but we didn't want that to be the sole purpose. We also wanted to reach the community. It was six years ago that we did the first one, and this year has been our

biggest crowd to date. We didn't expect this many," said Gurnsey.

The Peers Community Youth Group meets every week. They do games, activities, mission trips, and lots more. When they do the drama performances, they are also known as the Livewires Drama Troupe.

Plans for next year's production have already begun.



no answering machine so you can leave a message on a Sunday? Apparently, this has been happening for sometime now.

The Weekly Anchor verified that the clinic's voice message on Friday evening, Saturday, and Sunday does not have, or offers, a method to cancel a Monday appointment. We could not source any public website, email address, or online cancellation policy for the Edson Medical Clinic. AHS states many clinics have a 24hr cancellation policy and some have late cancellation fees. Our attempt to call the clinic directly to inquire, resulted in a wait time longer than our staff had available.






It has been a very interesting experience to see firsthand in San Carlos Mexico

how the volunteers are making such a difference helping wildlife.

Rescue, Rehabilitation, Investigation of the Fauna Silvestre (CRRIFS) is a non-profit organization that does whatever they can to rescue wild animals from risky, sick, or injured situations. They treat the animal until it's well enough to be released back into the wild. In some cases rescued animals can not be released as they wouldn't survive So, CRRIFS looks after them until the day they are adopted or die.



dove chicks, horned owls, and even a bobcat. Diana Barreto. the local

veterinarian for CRRIFS, says, "We have three adult male tortoises and one female that will be with us at the centre for the rest of their lives. One was attacked by some dogs. I had to amputate his leg. It would be hard for him to survive without help so he will remain here with us. Another tortoise we have, his owner died and there's no other family members to take him. Tobias is 50 years old and will remain with us now in his retirement."

I asked Diana how old she was when she knew she wanted to become a vet, she responded, "I was just five years old. I wanted a dog, but my parents didn't want any animals in the house. So I started to grab animals from the street, cats and dogs, and would hide them in our porch. One of them had a weeping eye, and I asked if there were doctors for animals. That's when my mom explained to me about veterinarians. I told my mom then that I wanted to be one." "The most fulfilling part of being a wildlife veterinarian is when we get to release an animal and say goodbye. I hope to never see them again and they can live out their natural lives," says Diana.

### **David Wayne Tindill**


It is with a heavy heart that the family of David (Dave) Wayne Tindill, announce his passing on December 9, 2024, in Carrot Creek, Alberta at the age of 68.

Dave was born in Vancouver, BC on April 27, 1956. He was the oldest son of John and Eileen Tindill. Dave grew up in Blue River, BC and Kamloops, BC; also lived with his grandfather, Thomas William Tindill, for a

He enjoyed taking pictures, most of them of the scenic mountains where he worked, the wildlife on the mine, or projects he built. If you were working on a project, home reno, car broken down, he would be first to roll up his sleeves and help. If you asked for help, he was certain to be there. He had a great sense of humor and loved playing pranks.

Dave and Rose had 2 sons, Donovan and Tyler. Dave and Rose also raised their nephew, Shannon James, during his school years, and Dave treated him like a son to this day. Dave enjoyed spending his

### **Canola's contribution to the Canadian economy reaches \$43.7 billion**

The value of canola to the Canadian economy has more than doubled in the past decade, and now generates an average of \$43.7 billion annually, according to a new independent analysis released today by the Canola Council of Canada (CCC). The canola sector supports an average of 206,000 jobs and \$16.3 billion in wages for Canadians from coast to coast.

"There has been a significant increase in the economic benefits from canola, impacting the Canadian economy on a large scale," says Chris Davison, CCC president and CEO. "From 2012/13 to 2022/23, the total annual impact of canola has more than doubled, increasing by \$30.5 billion."

The report was developed by GlobalData Plc, a leading agri-business research firm. GlobalData used best practices for economic analysis to calculate total impact, jobs and wages that are generated as Canadian canola is developed, grown, processed and utilized. The report includes the latest data for 2022/23 and previous years (which are officially revised and updated over time), and presents averages of the three years, 2020/21-2022/23. This is the fifth time GlobalData (formerly LMC International) has done this analysis on the canola value chain.

The study also shows how significantly canola's impact has grown over the last decade, along with the impact of domestic processing expansion and the burgeoning biofuels market. Since 2012/13:

The total wage impact of the sector has increased more than 80 per cent to its 2022/23 peak, adding over \$8 billion in wages to the Canadian economy.

Domestic canola processing and refining have expanded significantly and in 2022/23, now generates more than six times the economic impact.

The economic contribution of canola-based biofuel production rose from \$70 million to \$1.1 billion in 2022/23.

The growth of the industry's impact is driven by several factors. The economic benefits from canola are higher when prices and volumes produced are higher. Over the years covered in the report there was impressive economic value-add in the canola sector, peaking in the most recent year included in the analysis, 2022/23.

As the crop is researched, grown, handled, processed and then distributed to customers around the world, jobs are created within the canola value chain and in sectors that provide goods and services to the industry. Canola oil use in biofuels also rose significantly and accounts for over 400,000 tonnes of oil per year today.

"This has been a period of major investment by the industry," says Davison. "With expansion underway in canola processing here in Canada, we are seeing a sizeable investment of capital and an important opportunity to support growth in valueadded production in the years ahead."

GlobalData analyzed 11 individual segments of the canola value chain, with the majority of economic benefits stemming from the business of growing canola. Beyond contributing significantly to farm family incomes, canola production drives investments in research, seed development, equipment, fertilizers, crop protection and a broad array of business management services. Together, these activities contribute approximately \$25 billion to Canada's economy each year.

"The canola value chain is committed to canola's continued success by improving production, nurturing opportunities for growth and diversification, and leveraging the unique qualities of our outstanding products," says Davison. "Canola's impact is felt across Canada and around the world, and it remains a source of immense pride for our industry."

GlobalData found that these effects are felt across the country, including by Canadians living far from where canola is grown and processed. While the greatest economic benefit is in the Prairies, canola also has a significant impact on the economies of Ontario (\$3 billion), Quebec (\$1.4 billion), British Columbia (\$627 million) and the Maritime provinces (\$205 million). *-Canola Council of Canada*
