YCE Multi-Plex revised grant moves ahead

Both Town of Edson and Yellowhead County councils approved excluding the Multi-plex facility gymnasium from the grant tendering process. If included in the revised grant application, there would be no option of eliminating this program area if tenders came in significantly over budget. Projections suggest it could exceed \$70M.

The grant being applied for is based on a construction cost of \$50M. The grant funding being applied for is \$20M. A revised grant application was needed with the switch to the new plan of transforming the Leisure Centre into the new Multi-plex facility. Both councils agreed the gymnasium will continue to be included in the project scope of work and tendering process, as will the costing of a second

arena. "Our intent is still to build the gymnasium and to include it in the scope of work and the tendering process, but just exclude it from the grant application," said County CAO Luc Mercier, during Yellowhead County's Council meeting on January 10.

The two municipalities jointly submitted a draft amended grant application to Government of Alberta ICIP representatives, with the preferred concept design and project costing, for review and feedback.

The representatives recommended the removal of the gymnasium component of the application, as the current costing projections exceed the \$70 million budget. By including this component, both municipalities would have been obliged to include the gymnasium in the final project regardless of tender results, and would therefore not have the option of eliminating this program area if tenders came in significantly over budget.

On January 10, both Councils voted to approve the joint

submission of the cost-effective concept design amended grant application to the Investing in Canada Infrastructure Program without the gymnasium program

area, and further, that Councils direct their respective Administrations to include the gymnasium in the overall project scope and for design and tendering

purposes. It will likely take 3 to 4 months to receive a response back on the revised application.

Town of Edson rejoins West Central Airshed Society

During the January 10 Town Council Meeting, the council received a report from the West Central Airshed Society (WCAS).

WCAS is an independent, non-governmental organization that specializes in monitoring air quality across Alberta. Gary Redmond, Executive Director of WCAS came out to Edson to update council on Edson's air quality as recorded over the course of 2022, and also invite the town to rejoin WCAS as a municipal member.

There are 10 Airsheds in Alberta with 87 monitoring stations and many more smaller monitoring sites operated by WCAS. These stations keep track of local air quality, focusing on air pollutants and meteorological conditions. WCAS also monitors fine particulate matter (also known as PM2.5) in the air that can be attributed to smoke or other emissions. According to their readings the Town of Edson has had a 'Low Risk' air quality for over 98.07% of 2022. All WCAS Data is available on their website.

Currently, WCAS has one air monitoring station in the Edson area, just north of the Weyerhaeuser OSB plant. However, they are hoping to add a new station east of Weyerhaeuser, while also moving the existing station into the town centre.

As a municipal member, the Town of Edson would be given access to many perks. these include,

but are not limited to, updated air data and expert analysis for municipal planning, special responses to issues, expanded awareness and/or outreach to the region, and briefings for elected officials. Membership to WCAS will cost the town \$1,500 a year. While the Town of Edson was a member of WCAS for many years, it stopped in 2018.

Councillor Ed Moore began the open discussion by asking, "Do vandals leave these stations alone, mostly?" "We have had some issues with vandalism," replied Redmond, "especially when the stations are a bit more remote. We have seen some challenges with that and we've increased our security around it."

Councillor Gean Chouinard asked how Edson compares in air quality to other towns in Alberta. Redmond responded, "I actually don't know the answer for 2022. We're working on that. We wait until the data is all quality assured, then compare trends. But typically I would answer that I think Edson enjoys pretty good air quality."

Mayor Kevin Zahara concluded the discussion by stating that they had done some investigation into why the town had ceased membership. "It looks like it was just an error administratively. So I think we'll get that rectified. We certainly want to be supportive as much as we can. It is important to monitor our air quality here in our community, especially with our industrial players here."

Replace the CPP?

Premier Danielle Smith is now floating the balloon of an Alberta Pension Plan (APP) to replace CPP.

APP proponents argue that Alberta has an overall younger population and would be able

to make smaller contributions to their pension plan, compared to what they contribute to the CPP now. Pensioners may also experience a short-term increase. However, there is a short-sightedness in this kind of thinking.

In 30 or 40 years our population may no longer be so young. An APP would likely end up being transferred into a smaller and less secure plan with higher unfunded liabilities. As with any financial plan, the broader one can diversify risks, and pool those risks across a diverse set of the population, the lower the risk is ultimately to the beneficiaries.

Public outcry caused her to walk back those particular comments. But those public reactions may pale in comparison to the potential backlash from fundamentally changing seniors' pension plans.

CPP is arguably one of the best examples of federal/provincial co-operation. At the end of September 2022, the Canada Pension Plan Investment Board (CPIB) reported net assets of \$529 billion, with a 10-year annualized net return of 10.1 percent — that's a pretty healthy return in these markets.

Recent polls show that the top issues for Albertans are the cost of living, healthcare, the economy, taxes, and housing. Yet Smith's attention remained fixed on her Sovereignty Act, an Alberta Provincial Police force, Health Savings Accounts, and now, an Alberta Pension Plan to replace the Canada Pension Plan (CPP).

Sadly, we have already seen this province's lack of long term planning in our long-term care facilities. Seniors endlessly on hold and even dying in acute care hospital beds while waiting for spaces in long-term care facilities. This has been a problem for many, many years.

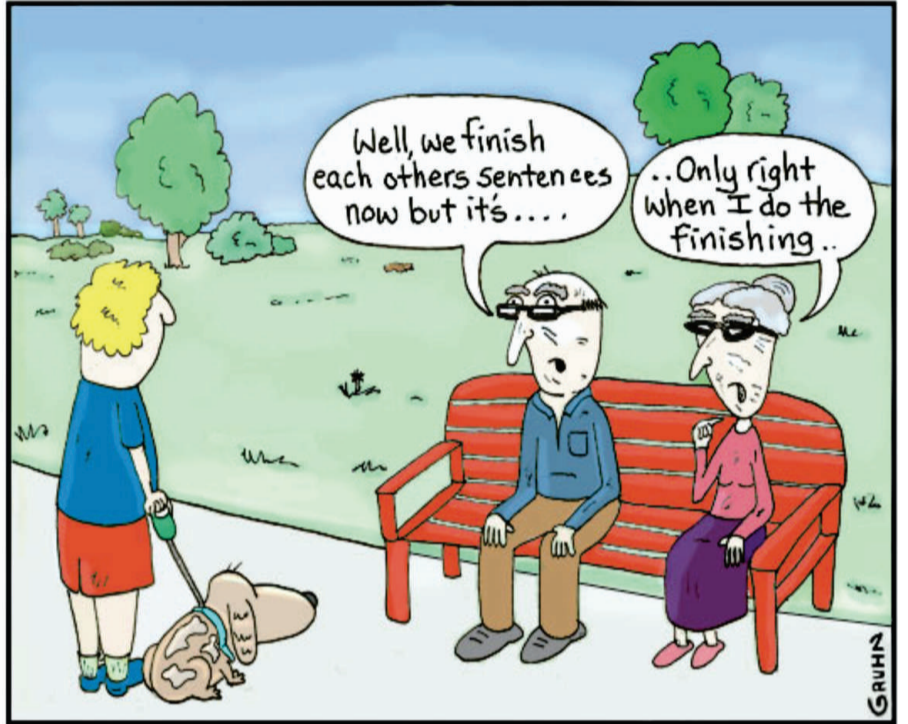
While the potential risks of establishing an APP are significant, the idea of having one is not new. The case for the move seems to hinge mainly on leveraging a short-term advantage and possibly investing in riskier assets for province-building.

Ironically, Smith continues to demand that the feds stay in their lane — perhaps she needs to look to her own advice on the issue of an APP.

West Yellowhead Trail Society: Pathway to the Park

During Yellowhead County Council's meeting on January 10, discussions focussed on the West Yellowhead Trail Society's Pathway to the Park Project.

On December 14, 2021, the West Yellowhead Trail Society (WYTS) presented their Pathway to the Park Project concept to Yellowhead County Council. The project proposes to construct a 26 km paved pathway from west Hinton to the Jasper National Park gate along the north side of Hwy 16. There are no fixed plans for the trail to extend into the Jasper townsite. The WYTS estimates construction costs of \$7 to \$10 million over a three year build.

In November 2022, the society requested a presentation to Council to provide a progress update.

Based on County Administration's recommendation, it was decided that the best course of action, assuming support from all parties, would be to begin with an ad hoc

committee to develop the business plan prior to making a formal request to Yellowhead County.

CAO Luc Mercier stated that it's Administration's position that if such a project would proceed, the apportionment of responsibility should be different than what was proposed, as Yellowhead County is being asked to take on most of the accountability once the project is complete. In addition to this, the current trail alignment conflicts with the current proposal for Yellowhead County land acquisition which should be dealt with prior to giving support.

"Although there is most definitely some merit to the project to enhance our region, the current plan does not fall within the County's Trail Master Plan and it does conflict with the County's long term plans in the area," stated Mercier.

As a result, Administration is recommending that council deny the request to join the ad hoc committee at this point in time, and with the current proposal. "This is a great board. I think they are providing something great for the region as a whole. But I feel this is a bit too soon for our

plans as a municipality," Mercier added.

Councillor David Russell expressed concerns with the cost of maintaining 26kms of paved trails as well as providing EMS services, "Costs could easily run away."

Council's consensus was that the timing was not good for this project.

Mayor Wade Williams said, "I also agree that the timing is not good for Yellowhead County with the other work we have going on. This needs to be delayed for us for a portion of time. I have also had some comments the last time this hit the paper, of this being a pathway to nowhere. Apparently it will go as far as the Jasper Park gates as that's as far as it could go without federal approval. My question is are the Feds going to continue it to Jasper [townsite] or will it be a pathway to nowhere?"

Council voted in favour of the motion to deny the request from the West Yellowhead Trail Society to join an ad hoc committee to develop a business plan for the development of the pathway to the park project and advise them that the County is not in support of the project at this current time and with the current proposal.

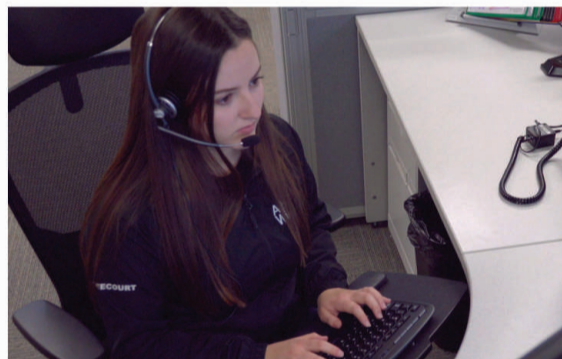

Fossil fuels once again the preferred source of reliable, affordable energy

The invisible hand of Adam Smith punched the world in the nose

It seems like just the other day that the wrath of the world was coming down on oil sands and coal.

To protect the atmosphere, Canada has been reducing coal-fired power generation for years. It started in Ontario, then moved to Alberta. Saskatchewan is next. New Brunswick is supposed to stop by 2030, but that province claims it can't be done.

Global coal consumption is rising again because it meets the cost and availability requirement created by energy shortages and rising prices. On Dec. 16, the International Energy Agency reported, "The world's coal consumption is set to reach a new high in 2022 as the energy crisis shakes markets."

For energy, the biggest single change in 2022 is the remarkable shift in public attitudes toward fossil fuels.

The global energy complex is under assault by Russia's invasion of Ukraine, the exposed shortcomings of wind and solar, years of underinvestment in fossil fuels, and rising inflation and interest rates.

But for the past 10 years, there has been an all-out crusade against fossil fuels. Oil company CEOs were branded climate criminals, and it was morally reprehensible to own fossil fuel company shares or loan money to oil, gas or coal producers. Elections were won in Canada, the U.S. and Europe on pledges to replace fossil fuels.

No cost was too great, because the cost of doing nothing, thus permitting unchecked climate damage, was greater.

What happened? How did the channel change so rapidly? Why, after years of public and political attacks on the source of over 80 per cent of the world's primary energy, has affordable energy on

demand now become more important than where it comes from?

Price, the most fundamental driver of economics and human behaviour.

The November 2022 global survey from public opinion research firm IPSOS titled What Worries The World tells the story.

IPSOS explains, "This 29-country Global Advisor survey was conducted ... among 20,466 adults aged 18 to 74 in Canada, Israel, Malaysia, South Africa, Turkey and the United States, 20 to 74 in Indonesia and Thailand, and 16 to 74 in all 21 other countries."

IPSOS charts the top six issues for the past two years. Poverty, crime, unemployment and corruption have always been important and consistently ranked among the top five.

In November 2020, inflation only registered among eight per cent of respondents. Two years later, it is 42 per cent. Coronavirus and the unemployment that accompanied the lockdowns were the top two issues in 2020. The others remain in a consistent range.

Two years ago was the peak of the "oil is dead" mantra, when many bright ideas for a fossil fuel-free future were concocted. In a post-pandemic world, multiple voices claimed we must Build Back Better, ensure a Resilient Recovery, engineer the Great Reset.

The plan was to use government policy and borrowed money to create jobs through the large-scale replacement of fossil fuels.

Coined the "energy transition," it was achievable and inevitable thanks to incredible advances in renewable energy cost and supply. Canada – the world's fifth largest combined oil and gas producer – could lead the charge with minimal disruption thanks to a new federally-funded retraining program for displaced oil workers. This was called a Just Transition.

What happened?

The invisible hand of Adam Smith punched the

world in the nose.

The only part of the demise of fossil fuels that was successful was reduced supply. As the economy recovered, consumers learned the hard way that low-carbon energy sources were terribly oversold in terms of reliability, and demand for fossil fuels outstripped supply.

Prices for fossil fuels rose at the same time that inflation and interest rates reduced disposal income.

As demand grew, fossil fuel shortages were reflected in the price. When Russia – one of the world's largest oil, gas and coal suppliers – invaded Ukraine, the gravity of the situation escalated immediately.

The IPSOS survey dramatically illustrates that the world's first concern as 2022 ended was the rising cost of everything.

We've been told repeatedly that continued fossil fuel consumption will cause serious climate disruptions. No expense today will exceed the cost of future damages.

However, the more pressing issue today is still being alive in 2050 because of the rising cost of everything, including energy. Worrying about what the temperature, storm intensity or chemical composition of the atmosphere may be in 28 years has become an unaffordable luxury.

So fossil fuels are once again what they have always been – reliable and affordable sources of energy.

Technologies to abate 99% of emissions from coal combustion can ensure reliable, secure energy

The past year witnessed a combination of factors that have caused the perfect storm for Europe's energy crisis, denting the impetus for renewables and the drive toward net-zero carbon emissions.

The energy crisis started in the late summer of 2021 when the economic rebound from COVID-19 lockdowns fired up global energy consumption. This caused oil, natural gas, and coal markets to tighten, sending prices up as demand pushed against what became apparent—insufficient supply.

One of the main issues for Europe is the depleted supply of natural gas. Due, in part, to Europe decreasing its domestic production of natural gas. The percentage of working gas in storage is approximately 74% in Europe, compared to last year when it was at 94%, according to data from Gas Infrastructure Europe.

Combined with a phasing out of coal and a bad year for wind production, the need for natural gas has risen.

In addition, there are also several issues on the supply side, including less maintenance of oil and gas fields during the COVID-19 crisis and less investment.

The Russian invasion of Ukraine added to the supply constraints for Europe, causing countries to

seek alternative supplies.

The energy crisis is set to continue and potentially worsen. Recently the International Energy Agency chief Fatih Birol and European Commission President Ursula von der Leyen announced in a joint press conference earlier in December that Europe could face a natural gas shortage of 27 billion cubic meters in 2023. That's equivalent to nearly 7% of the region's annual consumption. The IEA also found that a supply gap of 57 billion cubic meters could emerge next year assuming a complete cessation of Russian gas supplies to Europe.

One of those alternative supplies is coal. Coal fired-power has made a comeback across Europe as it becomes recognised for its energy reliability at a time when it is most needed.

Coal use rose in December 2022, when cold weather quieted wind farms and strained the electricity system. The EU generated 22% of its power with coal in the first two weeks of December. That is up from 17% in the same period last year and from the 15% average for the whole of 2021.

Across Europe, countries have passed laws to restart coal power and have ramped up coal production.

Germany: On 8 July, the German parliament passed a new energy law. The law states that extinguished and decommissioned coal-fired power plants could start again. The new legislation will allow 8.2 GW of coal-fired power plants to be placed in reserve supply – both hard coal (6.3 GW) and lignite (1.9 GW).

Czech Republic: The Czech Republic have decided to increase domestic coal production and extend the life of their extinguished power plants. The SM mine in the Ostrava-Karviná basin, which was slated to stop operating as early as this year, is now set to run until at least 2024.

Netherlands: An emergency return to coal has been

initiated, where earlier regulations stipulated that their functioning would be limited to 35% of capacity.

France: They plan to re-open the 595 MW Emile Huchet 6 coal-fired unit, which closed on 31 March.

In total, 13.5 GW of coal-fired standby will be used by power plants throughout the European Union. This will add 12% percent to the EU's existing coal fleet (109 GW) and only 1.5% to its total installed generation capacity (920 GW).

Coal should not be viewed as a temporary measure. Technologies and processes exist that can abate up to 99% of emissions from coal combustion, but more investment is needed especially in the developing world. These include high-efficiency low-emissions (HELE) power systems, carbon capture and storage (CCS), coal gasification, coal-to-hydrogen, and the production of ammonia-based products to make fertiliser or used as a hydrogen carrier.

If Europe upgraded its subcritical coal-fired power plants to ultra-supercritical plants (USC), instead of having them as stranded assets, coal would ensure reliable and secure energy 24/7 when the "Dunkelflaute" weather fails to provide the required energy.

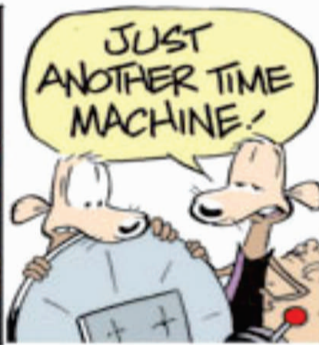

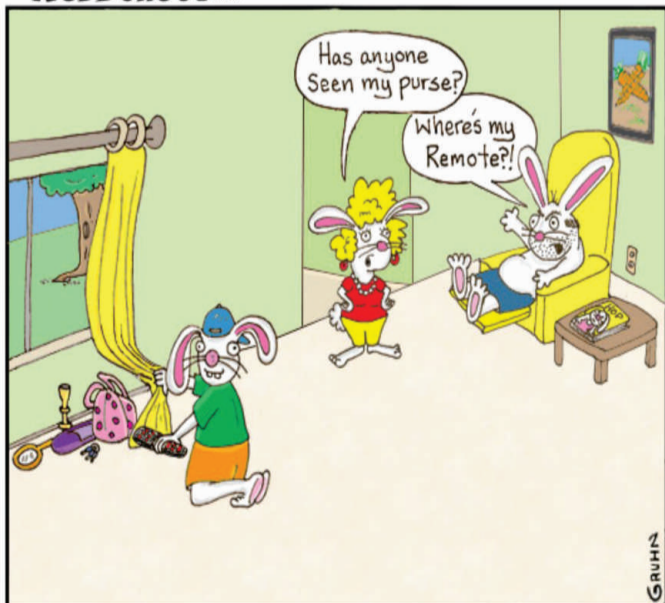

This is happening on free fishing days, so no license is needed and is open to all ages. The event will be on February 18 running from 1-3 pm.
