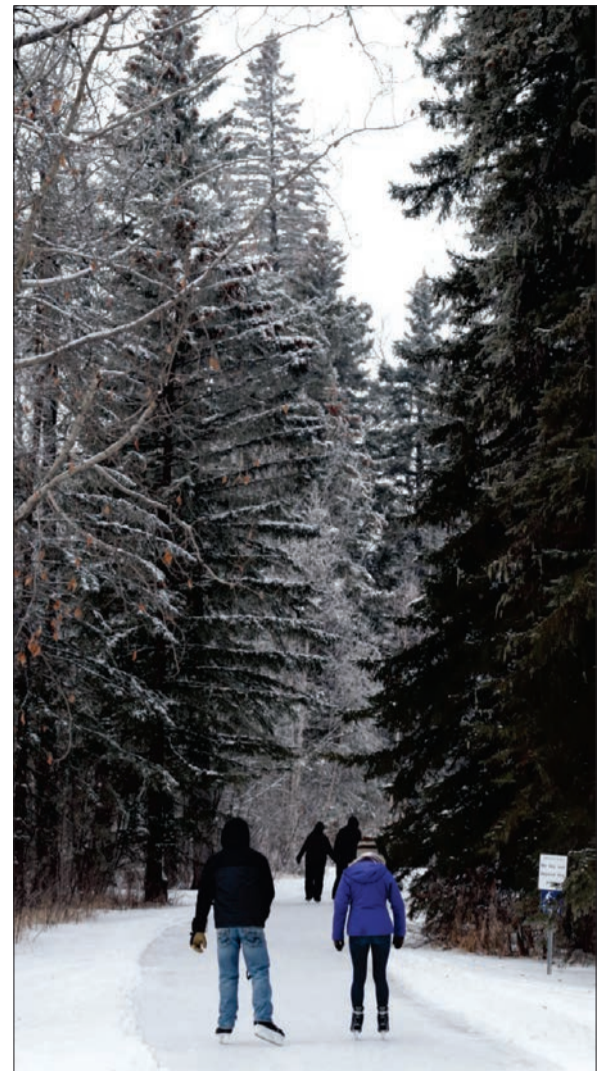
from a storybook. By following the signs you could enjoy the full story.

Questions raised regarding hot tub leak at Leisure Centre

Hot tub to remain out of service; focus centered on YCE Multiplex construction

On January 17, Edson's Town Council voted on whether to direct Administration to proceed with an additional investigation into the ongoing leak of the hot tub at the Edson and District Leisure Centre. The presentation on the matter was made by General Manager of Community and Protective Services Bob Beck, and Recreation Manager Krysta Hawboldt.

During the assessment of the facility in fall of 2022, leakage from the existing hot tub was confirmed on the exterior of the building and in the basement of the facility.

Council was shown the water issue during a facility tour in 2022. It was noted that this was a longstanding issue that has been worked on multiple times with no resolution, prior to the 2022 assessment.

With the Town and County actively pursuing redevelopment of the Leisure Centre, including construction of a new aquatic facility, questions have been raised regarding shutting down the existing hot tub for the foreseeable future of the current facility. The closure of the hot tub would be a significant loss of amenities for facility users.

The architectural and engineering team working on the YCE Multiplex project have recommended against reopening the hot tub until the cause of the leakage is determined and it is confirmed that the subsurface conditions in and around the hot tub pose no hazards. In particular, the engineer and contractor raised concerns that there may be potential voids in the ground caused by the long-term leak of water from the hot tub.

Given the costs involved in exploring and implementing interim solutions, it is unclear the extent to which staffing and financial resources should be invested in solutions.

The preliminary estimate for the engineering/consulting work to investigate the hot tub matter is approximately \$50,000. The Town office states that the costs of actual repair or temporary solutions are hard to predict without the engineering study, however, one community in Alberta is currently planning to replace their hot tub at a cost of approximately \$450,000. This is also a cost-shared facility with Yellowhead County.

Although the County is aware of the issue, they have not yet been formally consulted on the matter of conducting additional investigations.

After further consultation with the design team, it is now recommended by Town Administration not to pursue further investigation.

Instead, the focus and resources should be put towards development of the new YCE Multiplex project. The uncertainty surrounding further investigative work would mean such efforts could potentially go to waste if no viable or cost effective solution

can be found.

Councillor Greg Pasychny stated, "I definitely do not support spending money on that hot tub."

Councillor Krystal Baier agreed with Councillor Pasychny, but also asked if there was a possibility of putting a portable hot tub in for temporary use. "I've seen hotels put Arctic Spa hot tubs in as their hotel hot tub. Is there any possibility that something like that could fit in the pool or aquatic centre at all?"

Beck answered that they would need to talk it over, however, "There are some code issues we might have, so it might not be so simple." Beck added that the cost of installing something like that may not be worth it, considering how long it would be in use. "It could be quite costly for us to do it. I know it sounds simple, but nothing is simple for government."

Councillor Peter Taylor stated that as a user of the pool he understood the desire to get the hot tub up and running, but he had no desire to sink money into the situation. "My only concern is if there's any damage, like underneath or in the ground, that may cause issues with future construction."

"[The architectural and engineering team] didn't seem concerned with that," answered Beck, "They're anticipating that we're demolishing that entire pool. So, I don't think they're concerned about that."

Councillor Taylor added, "I guess the challenge is now, that we have a significant portion of that facility that is unavailable. I hate to think about reducing fees or something like that, but we are asking people to pay the same amount that they would when they had a hot tub."

Beck responded, "It is a significant loss of amenity and we're hearing from people that it is a beloved part of the pool, and people are missing it."

Chief Administrative Officer Christine Beveridge added that Administration would require a motion to further investigate the options, be it fee reduction or otherwise."

Councillor Pasychny added, "I understand that it's a loss, but at this time we need to focus on the new facility and get shovels in the ground so we can get this thing built."

Councillor Trevor Bevan said that he agrees with Councillor Pasychny. "I wouldn't support lowering any fees, because there's only a handful of people using it." He also added that he wouldn't support the temporary hot tub idea because if the cement does not support it, it would only lead to more issues.

Mayor Kevin Zahara concluded the discussion by saying that when he saw this item on the agenda he felt just like the rest of council. "It's up to \$50,000 and what comes after the \$50,000? We've got a 40 year old building and all of a sudden you do something and something else breaks. It's unfortunate. I know

people are very disappointed. But I think it speaks to why we are building a new facility, and why the urgency to get shovels in the ground this year."

Following the report, Council voted against the motion to proceed with additional investigation into the hot tub issues. Resources will instead be focused on the development of the new facility.

"We understand that the hot tub is a popular feature for facility users, but, considering all of the information, Council felt it wouldn't be fiscally prudent to move forward with putting any more resources towards this issue. I know this isn't the news anyone wants to hear, but our focus needs to be on the new facility which will hopefully break ground later this year," Edson Mayor Kevin Zahara stated later in a release.

Administration will continue to review programming to ensure quality and value for patrons of the facility until the new multi-plex is constructed.

Town Council Highlights:

Fees and Charges Bylaw

Amendment: Council passed an amendment to the Fees and Charges Bylaw. This fixes some clerical errors in the original bylaw, adding some omitted discretionary use fees

for development permit applications, and enhancing clarity in other areas of the bylaw.

New FCSS Advisory Board Bylaw:

All three readings were given to the Family and Community Support Services Advisory Board Bylaw. This Bylaw establishes a new FCSS Advisory Board which would provide recommendations to Council regarding FCSS programs, goals, and initiatives. The creation of this board, with public-at-large members, will increase public engagement within the FCSS program, aligning with Council's Strategic Plan and the Town's Public Participation Policy. Recruitment to the board will begin in the coming months.

NRED Grant Funding

Application: Council has approved an endorsement letter for Administration's application to the Northern and Regional Economic Development (NRED) Program for funding towards the development of an Economic Development Strategy. The project to create the strategy was already approved within the 2023 budget but, if the grant application is successful, it would reduce the costs to the municipality. The Economic Development Strategy would establish a clear vision, strategies, and action items to guide economic development initiatives for the community.

Speak to them about where they grew up and what it was like. Do they have any

importance of reading and engaging in literacy activities as a family. This year's theme is Celebrate Your Heritage.

By reading to children and engaging in fun literacy activities regularly, adults actively keep their own skills sharp and also help children improve their skills. Family literacy activities also strengthen the relationship between family members which, in turn, encourages lifelong learning.

Parents' reading habits play a large role in determining how often kids read. 57% of kids who are frequent readers have parents who read books 5-7 days per week, compared to only 15% of kids who are infrequent readers.

This year's theme can offer fascinating opportunities to explore your family's history together. Research shows that kids are emotionally healthier and have a better sense of self if they've been taught about their relatives and their family history. Below are a few activities to try at home.

Look at a map. Whether it be a map or Google Earth, you can learn a lot about geography by looking at a map.

Read a story. There are lots of books about different places and cultures. Visit your local library and ask the librarian for books about your heritage.

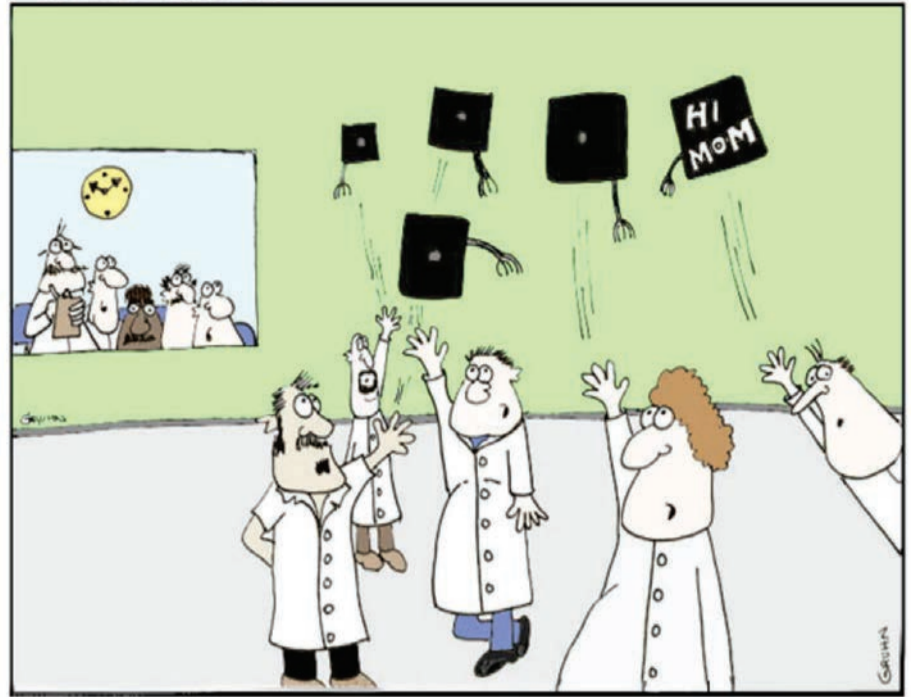
Learn about where you live. Do you know about the history of where you live? Together as a family, learn about the culture and heritage of the place you call home.

Edson RCMP arrest and charge same male for possession of stolen truck

(RCMP) – On Jan. 5, 2023, an Edson RCMP Officer on patrol observed a vehicle matching the description of a truck stolen from the Whitecourt area last month.

The same truck was also believed to be involved in an attempted theft at a local business in Edson.

The RCMP Officer circled around to confirm the license plate but the truck fled the area.

The officer was able to positively identify the driver before he made his escape. Police patrolled the area, but were unable to locate the vehicle.

Hours later, officers located the stolen vehicle at the last known address of the identified suspect and were able to make the arrest.

A 40 year old resident of Edson, was charged with:

- Possession of stolen property obtained by crime
- Flight from a Peace Officer
- Fail to comply with a Release Order

At the time of the arrest, the accused was wanted on a warrant for fail to attend court for a similar matter, where on September 9, 2022, he was arrested and charged by the Edson RCMP for possession of a stolen truck, stolen camper and a stolen license plate.

The accused was brought before a Justice of the Peace where he was release with his next court appearance date set for Jan. 17, 2023, at Edson Provincial Court.

NOTE: A charge should not be considered as evidence of guilt. In Canada, all persons are considered innocent until proven guilty in a court of law.



During Yellowhead County's Governance and Priorities (G&P) meeting on January 17, Council reviewed a draft of the revised Municipal Development Plan (MDP). 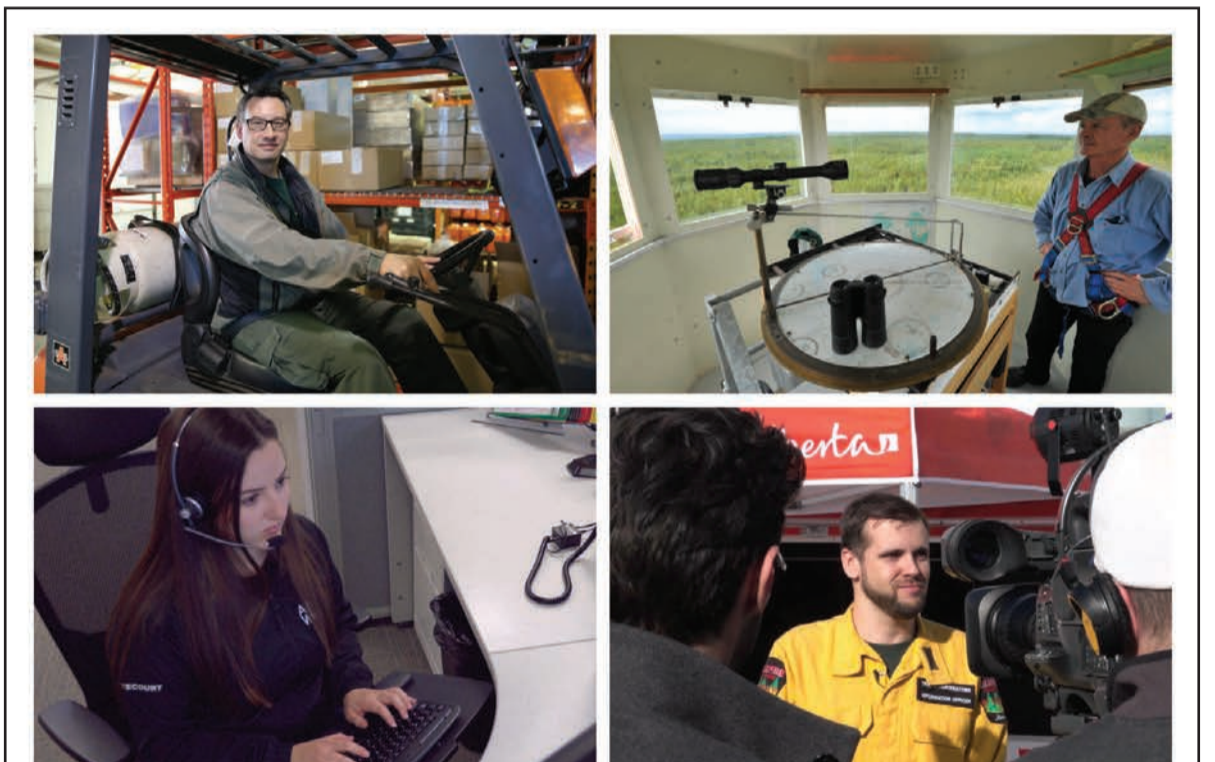

What is depression in children and teens?

(AHS) Depression is a serious mood disorder that can take the joy from a child's life. It is normal for a child to be moody or sad from time to time. You can expect these feelings after the death of a pet or a move to a new city. But if these feelings last for weeks or months, they may be a sign of depression.

Experts used to think that only adults could get depression. Now we know that even a young child can have depression that needs treatment to improve. As many as two out of 100 young children and eight out of 100 teens have serious depression.

Still, many children don't get the treatment they need. This is partly because it can be hard to tell the difference between depression and normal moodiness. Also, depression may not look the same in a child as in an adult.

If you are worried about your child, learn more about the symptoms in children. Talk to your child to see how they are feeling. If you think your child is depressed, talk to your doctor or a counsellor. The sooner a child gets treatment, the sooner they will start to feel better.

• What are the symptoms?

- A child may be depressed if they:
- Are irritable, sad, withdrawn, or bored most of the time.
- Do not take pleasure in things they used to enjoy.

• A child who is depressed may also:

- Lose or gain weight.
- Sleep too much or too little.
- Feel hopeless, worthless, or guilty.
- Have trouble concentrating, thinking, or making decisions.
- Think about death or suicide a lot.

Both very young children and grade-school children may lack energy and become withdrawn. They may show little emotion, seem to feel hopeless, and have trouble sleeping. Often they will lose interest in friends and activities they liked before. They may complain of headaches or stomach aches. A child may be more anxious or clingy with caregivers.

Depression can range from mild to severe. In its most severe form, depression can cause a child to lose hope and want to die.

Whether depression is mild or severe, there are treatments that can help.

How is depression diagnosed?

To diagnose depression, a doctor may do a physical examination and ask questions about your child's past health. You and your child may be asked to fill out a form about your child's symptoms. The doctor may ask your child questions to learn more about how he or she

thinks, acts, and feels.

How is it treated?

Usually one of the first steps in treating depression is education for the child and his or her family. Teaching both the child and the family about depression can be a big help. It makes them less likely to blame themselves for the problem. Sometimes it can help other family members see that they are also depressed.

Counselling may help the child feel better. The type of counselling will depend on the age of the child.

Medicine may be an option if the child is very depressed. Combining antidepressant medicine with counselling often works best. A child with severe depression may need to be treated in the hospital.

There are some things you can do at home to help your child start to feel better.

- Encourage your child to get regular exercise, spend time with supportive friends, eat healthy foods, and get enough sleep.
- See that your child takes any medicine as prescribed and goes to all follow-up appointments.
- Make time to talk and listen to your child. Ask how they are feeling. Express your love and support.
- Remind your child that things will get better in time.

What should you know about antidepressant medicines?

Antidepressant medicines often work well for children who are depressed. But there are some important things you should know about these medicines.

Children who take antidepressants should be watched closely. These medicines may increase the risk that a child will think about or try suicide, especially in the first few weeks of use. If your child takes an antidepressant, learn the warning signs of suicide, and get help right away if you see any of them. Common warning signs include:

- o Talking, drawing, or writing about death.

- Giving away belongings.
- Withdrawing from family and friends.
- Having a plan, such as a gun or pills.

Your child may start to feel better after one to three weeks of taking antidepressant medicine. But it can take as many as six to eight weeks to

see more improvement. Make sure your child takes antidepressants as prescribed and keeps taking them so they have time to work.


A child may need to try several different antidepressants to find one that works. If you notice any warning signs or have concerns about the medicine, or if you do not notice any improvement by three weeks, talk to your child's doctor.

Do not let a child suddenly stop taking antidepressants. This could be dangerous. Your doctor can help you taper off the dose slowly to prevent problems.

The family will not be holding a service at this time. In lieu of flowers, donations can be made to a charity of your choice in Joe's name.

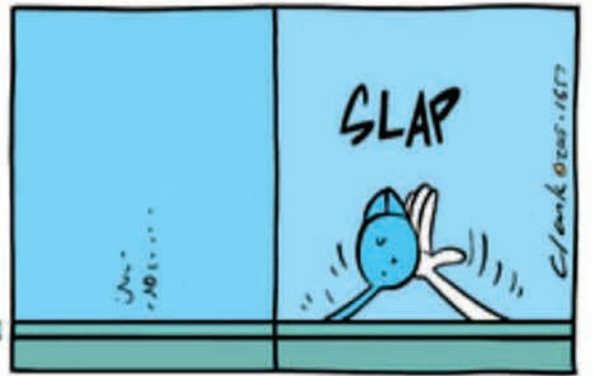
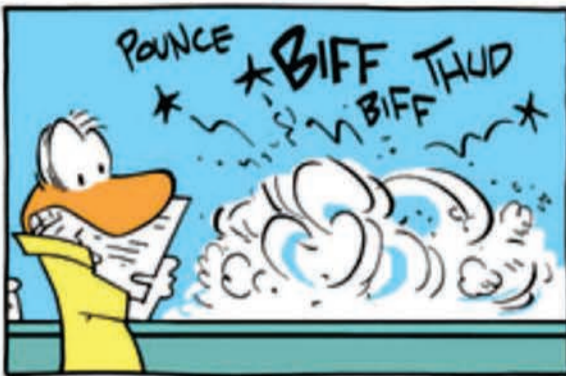
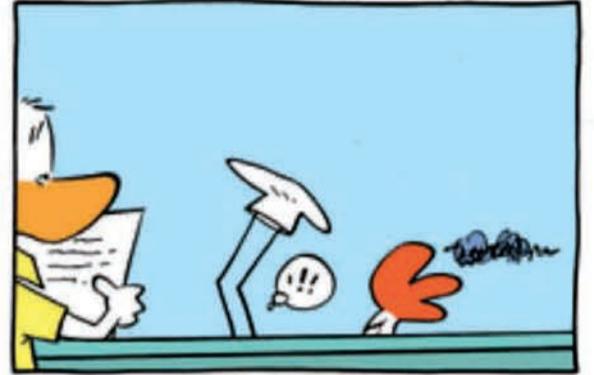

Alberta hay production in 2022 improved over 2021

“Significant rain throughout the majority of the province during the spring and early summer months set the stage for yields to return to normal,” says Ryan Furtas, market analyst with the Alberta government. “Persistent dry conditions for the majority of the summer allowed for much of the hay crop to be high quality and hay season to be relatively stress free.”

According to the Alberta crop report, yield for first cut dryland hay was estimated at 1.6 tons/acre (above the 5-year average of 1.4 tons/acre). Quality was rated as 5% poor, 22% fair, 61% good and 12% excellent.

For irrigated hay, yield was reported at 2.2 tons/acre, below the 5-year average of 2.4 tons/acre. Quality was rated at 3% poor, 30% fair, 62% good and 5% excellent.

Approximately 90% of dryland hay in the province was from the first cut. Some producers, particularly in the South Region, failed to harvest a second cut, or harvested very little. The

remaining 10% was from the second cut, with yields estimated at 1.0 tons/acre, compared to the 5-year average of 1.1 tons/acre.

For irrigated hay, first cut accounted for 60% of the total with the second cut accounting for 36% and third cut accounted for the remaining 4%.

“Alberta hay production has experienced a series of production issues in the past 5 years,” points out Furtas. “2018, 2019 and 2021 were low production years. The annual average cost of Alberta hay has increased 4 of the past 5 years, with 2020 being the lone exception. Prices for a ton of hay have more than doubled in value since

“The back to normal production in 2022 was more than welcome by producers, but it will take at least another year of normal production to see hay prices potentially decrease.”

Hay prices are also contingent on the Western Canadian feed grain complex which has been demonstrating historically, and at times, record high prices since the fall of 2021. Feed grains are expected to be historically high priced for the remainder of 2022 and into 2023, which contributes to high hay prices. “Feed and forage availability for 2022 is considered to be mostly adequate, with only a few livestock producers indicating a surplus. Regardless of availability, hay prices are likely to remain on the high side for the rest of the 2022-23 crop year. A return to normal production for hay was critical. While the high prices are not helping livestock margins, they do help hay producer margins,” say Furtas. *AgriNews*

Yellowhead County Council Highlights: Jan. 10

Bylaw 20.22 Public Hearing – A Public Hearing was held for Bylaw 20.22. The proposed bylaw would allow for a property in NW 32-53-17-W5M to be redistricted from Rural District (RD) to Country Residential District (CRD) and Protection District (PD). This would allow for a subdivision of the property to create two new country residential parcels. The Bylaw will be brought back to an upcoming meeting.

Council Strategic Priorities – Council has scheduled their annual review of their strategic priorities as part of the current 2022-2025 Strategic Plan. This plan creates the foundation for Council's direction for the municipality and focuses on current and future priorities for Yellowhead County. The 2022-2025 Council Strategic Plan is available at www.yhcounty.ca/strategic-plan.


Cascade Power Plant – Following an invitation from Kinetico, Council will be visiting the

Cascade Power Project site for a tour of the new plant. The new 900-megawatt (MW) power generation facility will have the capacity to supply over 8% of the province's average electricity demand and will be fueled by natural gas. The power plant is scheduled to commence operations in 2023.

Municipal Planning Commission – Municipal Planning Commission Bylaw 23.22 passed second reading by Council. A Municipal Planning Commission would give the municipality another option for facilitating development requests for unique or contentious development proposals. This approach allows for increased public engagement during the development approval process. The item will be brought back to Council at a later date for continued deliberation and a possible third reading.
