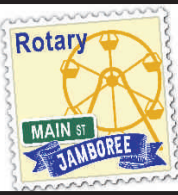
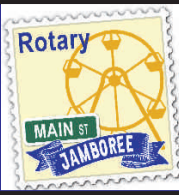

3-year-old's 'Hydration Station' a big hit

If you've been out and about near 5802 12 Ave lately, you may have noticed something new that is quickly becoming a

community favorite. 'Decklyn's Hydration Station' aims to provide "people and pups" with drinks and even snacks to help "beat the heat!" 3-year-old Decklyn Casorso

was playing outside during our recent heat wave with his mom, Rachel Phillips, when two young girls walked by. Without hesitation, Decklyn ran up and tried to share his

water bottle with them. From there, Decklyn and his mom came up with an idea to help out members of the community.

"I thought it was a really great opportunity to build on – teaching him about kindness, sharing, and paying it forward," said Rachel. "We talked a lot about it being really hot and people being thirsty and how we could help. The idea was born with a little help and encouragement from me, but he has kept it going and always asks if we need to 'fill up.'"

Decklyn and Rachel fill up the station every morning with drinks and snacks. "People are welcome to take whatever they like, as much or as little, for free!" said Rachel. "He gets so excited to come home and check how many drinks and snacks are gone!" The pair has even included a dog dish that they refill twice a day.

The news of this sweet idea to pay it forward quickly spread on social media, and Rachel said that the response from the community has been "incredible."

"We have come home to flats of water, juice boxes, snacks, gifts for Decklyn, cards, cash donations - Panago Pizza sent over a free pizza for Decklyn, Sobeys sent over water, juice and a stuffed animal for Decklyn, [and] Rickis All Day Grill has offered ice for the stand anytime Decklyn needs

it!" said Rachel.
 "It's honestly so overwhelming and heartwarming. We started this for fun and to encourage kindness - and to see so many people support and encourage Decklyn just makes me so proud to be a part of the Edson Community!" she added.

Decklyn has even become a little bit of a local celebrity. "I think the most surprising thing has been the amount of people who recognize Decklyn out and about!" said Rachel. He has also had a video made about him and an Edmonton radio station posted about him and his stand on social media. The Hydration Station has received donations all the way from the US.

Still, even with all the attention, Decklyn remains humble and his "very shy and cautious" self. "He loves seeing kids stop by the stand but doesn't always know what to do when people say hi!" said Rachel. "Attention is not something he looks for - we do talk about it a lot and he always says "thank you everyone" even though he may not say it in the moment."

Decklyn and his family plan to keep the station open all summer long, and it might stick around even longer than that. "Maybe we'll do a different station for every season - who knows! The possibilities are endless!" said Rachel.

Rachel also had a message for the community: "There are not enough words to express how meaningful the outpouring of support has been but I would like to say a HUGE thank you to EDSON! You have made a little boy so incredibly happy and proud of his creation!"

Town begins to expand programming and event options post-restrictions

The relaxing of restrictions due to COVID has allowed the Town to once again expand their programming and event options.

Community Development manager Tanya Byers delivered a presentation to Council at their Committee of the Whole meeting outlining the successes, disappointments, and challenges for June and early July community initiatives as well as providing a brief overview of what is coming this summer.

Byers praised her department staff for their resiliency and creativity during the pandemic as they strived to find new and innovative ways to bring seniors and family programming to the community while dealing with ever changing public health restrictions and regulations.

The Senior's drive-thru breakfast was noted as a successful event with approximately 200 seniors participating. Byers said not only was it a different style of event but attracted different individuals for some of whom the breakfast was the first Seniors event in which they have participated. Byers said the virtual presentations were understandably less well attended as while there are some tech savvy seniors in Edson there are some who struggled with the virtual presentations utilized while restrictions were in place.

The Mountain biking course at

Wilmore Park had 73 participants and was very well received. Byers said the course will definitely be run again possibly as soon as September.

Other well received initiatives include the Diversity and Inclusion video series, Youth Council, and the Community Mural Mosaic with all 500 tiles distributed and due back in the next week.

Unique initiatives that have also provided a few challenges include the scavenger rock hunt and the story book walk. Both were victims of vandalism or theft with some rocks being stolen and some vandalism of the story book stations, however, Byers said that the Town would not allow what may possibly be only one person ruin it for the rest of the Community and they would continue to offer these types of events. Overall the feedback from the Community for those walks has been positive.

Youth InterAgency is back up and running with fun activities organized for local youth throughout the summer.

Byers admitted the Canada Day events were "a bit underwhelming" and said with restrictions lifted and more time to plan the staff is looking forward to August and being able to host larger more interactive events.

"Community Services has done an excellent job," said Councillor Bevan, "And I am sure they will continue to do so." He added that if Edsonites have any ideas for events to let the

Edson Chrysler holds Grand Opening

On July 9, Edson Chrysler held a Grand Opening Celebration to commemorate their re-opening in their new location.

The event saw an “excellent turnout” with approximately 175 people in attendance. The guest list included many local dignitaries, such as the Mayors of Edson and Yellowhead County, MLA Martin Long, and MP Gerald Soroka.

The Grand Opening involved a ribbon cutting ceremony and was catered by local restaurant The Fresh Vine. Wine and other drinks were also available to be enjoyed by attendees.

Unlike many re-openings, this event was not about selling or bringing in business. “This was a celebration of what we've accomplished as a town. It wasn't just Edson Chrysler,” said Owner Kamsen Iyer.

Iyer spoke about the “horrible tragedy” that occurred at his business on December 9, 2019. An act of arson was committed in the early morning hours and completely destroyed the original Edson Chrysler building.

“As the owner of a business that I'd been building for 18 years in Edson, it was a very dark day because we lost everything that I'd been building, overnight. In a complete loss. Burned down to the ground,” Iyer said.

Iyer spoke of the tenacity and perseverance from his staff right from the start. After the December 9 loss, his team worked hard to get themselves reopened in two temporary locations quickly. “They

bought new hoists, new tools, new desks, new computers, and they set up in two new locations in 35 days with Christmas and New Years in the middle,” said Iyer. “35 days and we were up and running again. And the town supported us through that whole time.”

Iyer then found out that the piece of land he had was no longer sufficient, as Chrysler considered the two-acre piece “too small.” “Because it was burnt, I was forced into a situation where I had to find a new piece of land,” he said.

Iyer saw an opportunity in a piece of raw farmland next door, but it came with its challenges. “I had to get that raw farmland purchased, rezoned from farmland to commercial,” explained Iyer. “I had to get services to it... and I had to get it designed and built.”

They also had to knock down an old farmhouse on the land. At the time, the land had still not been rezoned, but the rezoning came through last August. “In 10-and-a-half months we built that dealership and that subdivision, which is a feat from anybody's standpoint,” said Iyer.

Iyer gave the Town “a lot of credit” for their work on the project. “Living in Edson for 20 years, we always hear how difficult it is to get things done in the Town of Edson, and that was not my experience,” said Iyer. “They worked with us, they worked as quickly as it could possibly be done, to assist in getting that dealership up and running. And that Grand Opening was a celebration of everybody's efforts.”

Iyer said that even with the extra challenges of Covid and price increases and many other obstacles, his staff took the “uphill climbing” in stride and helped get the new dealership open.

The building itself is not like any Chrysler dealership you're likely to have seen before. Iyer took the time to take his builder through another new Chrysler dealership in Alberta, and then walked him through a Porsche dealership. “I told him, 'We want a Chrysler dealership, but we want it built to Porsche quality,’” Iyer said. “The quality is amazing. It's second to none.”

While an out-of-town builder had to be hired to take on such a large build, Iyer used as many local trades and companies as he could. Supporting local

wherever he could was important to Iyer with this project.

All 28 of Iyer's staff members were thanked at the Grand Opening for everything they had done. “Every single person that was employed that morning, as of that Grand Opening, I gave them \$1,000 bonus as a thank you from me to them... whether they worked there for a day or 18 years,” Iyer said.

“We have a very loyal staff that have stayed with our company from the beginning, and we maintained all of them. Through a fire, during Covid, and all of the challenges of no business, and we still kept all of our staff during that time,” said Iyer.

For now, Iyer and his team are focusing on getting inventory. Inventory and parts challenges are being faced across the country, yet another side effect from the pandemic.

Compassion first...

stating, "It was a loophole. It might be legal, but it's not ethical."

The fact remains

that the congregations that occupy the pews of Catholic churches across the country are very compassionate and generous people. So why does it appear that the Church hierarchy has dumped the 'blame' for the \$21 million shortfall onto its own congregations?

The Catholic Church is literally hierarchical in nature and has untold billions in assets, and each Archdiocese also has the ability to implement special fundraising and second collections. So it would be with great assurance that the relatively small amount of \$21 million could be raised quickly, if a serious effort from the top was made. Many Archdiocese often have 12 or more scheduled special collections throughout the year—including a special collection for the Pope's pastoral works.

Recognition now must be given to Saskatchewan's Catholic Bishops who are boldly forging ahead alone with fundraising efforts to honour this old commitment.

With a history of delays in revealing the names of abuser priests to its internal financial scandals—it's a shame that the vast majority of the Church hierarchy has once again not been forthcoming in the matter of compensation for residential school survivors or with a Papal apology on Canadian soil.

Loopholes, complicating legal structure, and decentralization to avoid liability at higher levels is not the answer—compassion is.

**A national Residential School Crisis Line has been set up to provide support for former students and those affected. People can access emotional and crisis referral services by calling the 24-hour national crisis line: 1-866-925-4419.*

The recent discoveries of sites where hundreds of children were buried near abandoned residential schools has deeply touched the country, and even stirred genuine anger.

For many years, hundreds of Indigenous testimonies have described the deaths of children at residential schools. However, the deaths of these young students, taken from their homes and put into state care at the mostly Catholic Church run schools, was brought to a shocking reality when ground penetrating radar identified hundreds of unmarked, undocumented graves.

The scale of these revelations is heartbreaking. Young children were torn away from their families and communities. Many died alone in these institutions characterized by a lack of compassion, cultural shaming, as well as emotional, physical and sexual abuse.

The intergenerational trauma of these schools carries forward even today.

The lives of these innocent children can never be replaced, but the vestiges of these atrocious 19th and 20th century colonial schools must be reconciled with Indigenous peoples, who have been so grievously impacted by these genocidal actions.

One of the Catholic Church's promises in the landmark 2005 "Indian Residential School Settlement Agreement" was to give its "best efforts" at fundraising \$25 million for survivors. After a decade, the church claimed it was only able to raise \$4 million, yet the other churches involved in the settlement paid their full shares.

The response of the Catholic Church's hierarchy to payment requests was to send their legal team into court to point to the "best efforts" clause, saying the church had tried its best. In 2015, a judge agreed and absolved the church of its legal obligation.

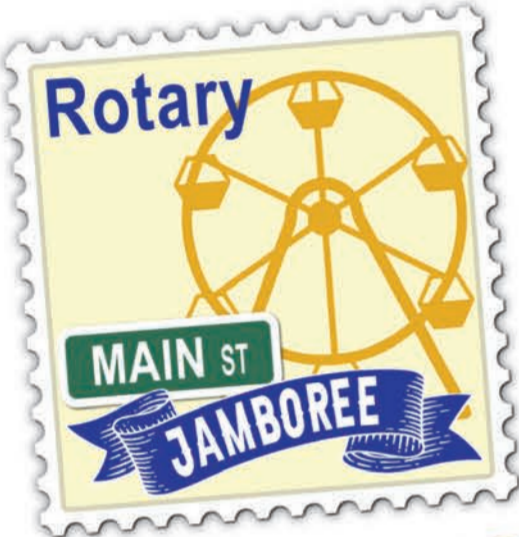

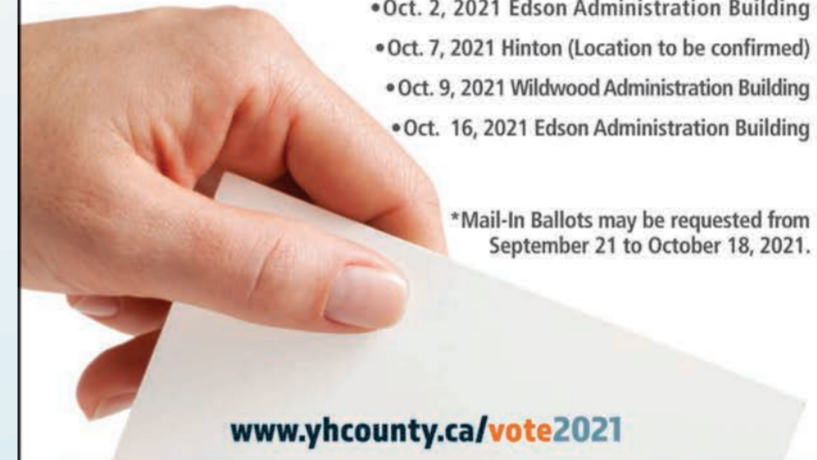

Duet Bike for Continuing Care

It has been a long time in the works, but after more than four years of fundraising and many gracious donations, the Continuing Care Unit has been able to finally purchase a Duet Bike.

Patty Mohns, Recreation Therapist in Continuing Care, explained that the bike was purchased from Mobility & Access Inc, a company that has been around for over 20 years.

The bike, a DUET Electro Pedal Assist, cost around \$11,000. "It comes with a battery that allows us to control the power assist when needing it, making it easier for climbing hills," said Patty. "The Duet bike is both a wheelchair and a bike. The wheelchair can be detached from the bike so we can go onto the unit, pick up the resident and bring them back to the bike, reattach the wheelchair and off we go."

Before riding the bike for the first time, all recreation and Adult Day Program staff had a full day of training. The training involved learning about depression in the elderly and how wheelchair biking can provide a complimentary or alternative treatment to medications.

It also involved learning all the aspects of the bike and included a practical portion where they were required to ride the bike as well as ride in the wheelchair. "Staff must be comfortable riding the bike and

know all aspects of the bike prior to taking a resident," said Patty.

"Wheelchair biking is an evidenced based treatment to address depression. The treatment blends the invigorating bike ride and a meaningful social discussion about the experience and past memories of biking," Patty said. "For optimal effectiveness the intervention would be for a two-week period, five days a week, and then followed by a maintenance period of two days per week for eight weeks."

Covid restraints on Continuing Care programs meant that the group was not able to start riding until July.

"We are not able to gather people together for the social discussion component; therefore, the program has been modified to be three afternoons per week and with the support of the Day Program staff."

So far, four residents have been able to participate in wheelchair biking. "The residents were picked based on history of depression, may be on medication for depression or based on signs and symptoms of depression," explained Patty. "Also, they are able to sit in an upright position, are medically stable, have predictable and controlled behavior, and have agreed to go." Patty said that other

residents are also hoping to try out the bike, so they will be trying to plan times to take them out as well. Some residents require the lift in order to get into the wheelchair, so the CCU needs assistance from nursing staff to do that. "They have been awesome," Patty added.

Feedback on the bike so far has been very

positive. "The residents like the bike, they say it is a smooth ride and are so happy to be out of the building doing something different," said Patty.

Resident Dana Nolette gave her review of the bike. "The experience is such a breath of fresh air. You get to see what feels like the world. It's a whole new atmosphere

going on the bike. I love seeing all the houses and how each one is designed," Dana said.

Other residents said they enjoyed the "freedom and how they loved how smooth the ride was. So enjoyable to be outside in the fresh air and able to see different things happening around the community."

GYPSPD Transportation Services FAQ and Information Guide

What Transportation Services are Offered through GYPSPD?

GYPSPD strives to offer a range of services that are fair and equitable. Board Policy 17 is aligned with the province's *Education Act* and the *Student Transportation Regulation*. Services are available for:

- **Eligible:** Students who live more than 2.4 km away from their designated school
- **Ineligible:** Students who live less than 2.4 km away from their designated school
- **School of Choice:** Students who chose to attend a school other than their designated school
- **Transportation Out of District:** Students who chose to attend a different school jurisdiction
- **Alternate Second Seat:** Students who require a reserved second seat on a different bus to an alternate address

What Transportation Services are School Jurisdictions Funded to Provide?

Alberta Education Transportation Funding is for:

- Students residing more than 2.4 km away from their designated school
- Students with special needs who require specialized transportation

Under the School Transportation Regulation, school jurisdictions are not required to transport students beyond their designated school.

How Do I Determine my Child's Designated School?

Please visit the Division's website at www.gypsd.ca under **For Parents/Student Transportation** and enter your home address on the link *What is My Designated School?*

Why does Transportation Services Charge Fees for Some Services?

Fees are established to support transportation services for the jurisdiction's families who request them and to ensure classroom dollars are not being used to address transportation service funding gaps.

User fees are charged to parents of students who access transportation services as a way to recover the unfunded costs. GYPSPD service fees are amongst the lowest in the province.

How is Eligibility for Transportation Determined?

- Alberta Education provides funding to eligible riders only.
- The distance of 2.4 kms for busing to the student's designated school is set by Alberta Education.
- The government sets eligibility based on the student's primary residence address and distance from home to designated school.

Do I Need to Register for the Bus?

NEW for the 2021/2022 School Year: All **new** and **returning** students requiring transportation services must register. Registration is now open.

How Do I Register for the Bus?

Registration for transportation services is at www.gypsd.ca under **For Parents/Student Transportation**. Only eligible riders are guaranteed a seat each year. All other riders are subject to seat availability.

IN THE MATTER OF the Certificate of Public Convenience and Necessity GC-133 approving the general route of the Project (Alford Creek and Elk River Sections), a proposed expansion of the existing NGTL System to meet existing and incremental firm service contracts for the receipt of sweet natural gas on the NGTL System as well as supply forecast requirements. The Project consists of approximately 85 km of 1,219 mm (NPS 48) pipeline loops in two sections:

- Edson Mainline Loop No. 4 (Alford Creek Section): approximately 45 km of pipeline beginning at SE 03-36-07 W5M and ending at NE 14-39-10 W5M.
- Edson Mainline Loop No. 4 (Elk River Section): approximately 40 km of pipeline beginning at SW 03-47-14 W5M and ending at NW 20-43-12 W5M.

NGTL proposes that the detailed route for the Project is as shown on the map in this notice. This notice is being published to comply with the requirements of paragraph 201(1)(b) of the CER Act. The pipeline section routes are proposed to cross those lands noted in the accompanying tables.

If you anticipate that your lands may be adversely affected by the proposed detailed route of the Project, you may oppose the proposed detailed route by filing a written statement of opposition with the Canada Energy Regulator (CER) within 30 days following the publication of this notice. The Statement of Opposition to the Detailed Route form can be found on the CER's website at www.cer-rec.gc.ca/statement-opposition. Any such statement must set out both the nature of your interest in the lands and the grounds for your opposition to the detailed route.

Where a written statement is filed with the CER within 30 days of the publication of this notice, the Commission of the CER (Commission) shall forthwith order, subject to certain exceptions as noted below, that a public hearing be held.

The Commission may at any time disregard any such written statement and is not required to take any action with regard to that statement if the person who filed the statement files a notice of withdrawal, or it appears to the Commission that the statement is frivolous, vexatious or is not made in good faith.

If the Commission determines to hold a public hearing, the Commission will fix a suitable time and place of the hearing and publish notice of the hearing in at least one issue of a publication, if any, in general circulation within the area in which the lands proposed to be acquired are situated. The Commission will also send such notice to each person who files a written statement of opposition with the CER.

If safe to do so and as the Commission deems necessary, the Commission or a person authorized by the CER may make such inspection of the lands proposed to be acquired, leased, taken or used for, or are affected by, the Project's construction.

During the hearing, the Commission will permit each person who filed a written statement to make representations and may allow any other interested person to make representations before it as the Commission deems proper.

The Commission will take into account all written statements and all representations made during the hearing to determine the best possible detailed route of the Project and the most appropriate methods and timing of constructing the Project. The Commission may impose in any approval such terms and conditions as it considers proper.

Where the Commission has held a hearing in respect of any part of the Project and approved or refused to approve the plan, profile and book of reference respecting that part, it will forward a copy of its decision and reasons to each person who made representation to the Commission during the hearing.

The Commission may, by order, fix an amount that it considers reasonable in respect

of the interim or final costs that are incurred by any person who made or will make representations to the Commission during such a hearing and that amount is payable, on an interim or final basis and without delay, to that person by NGTL.

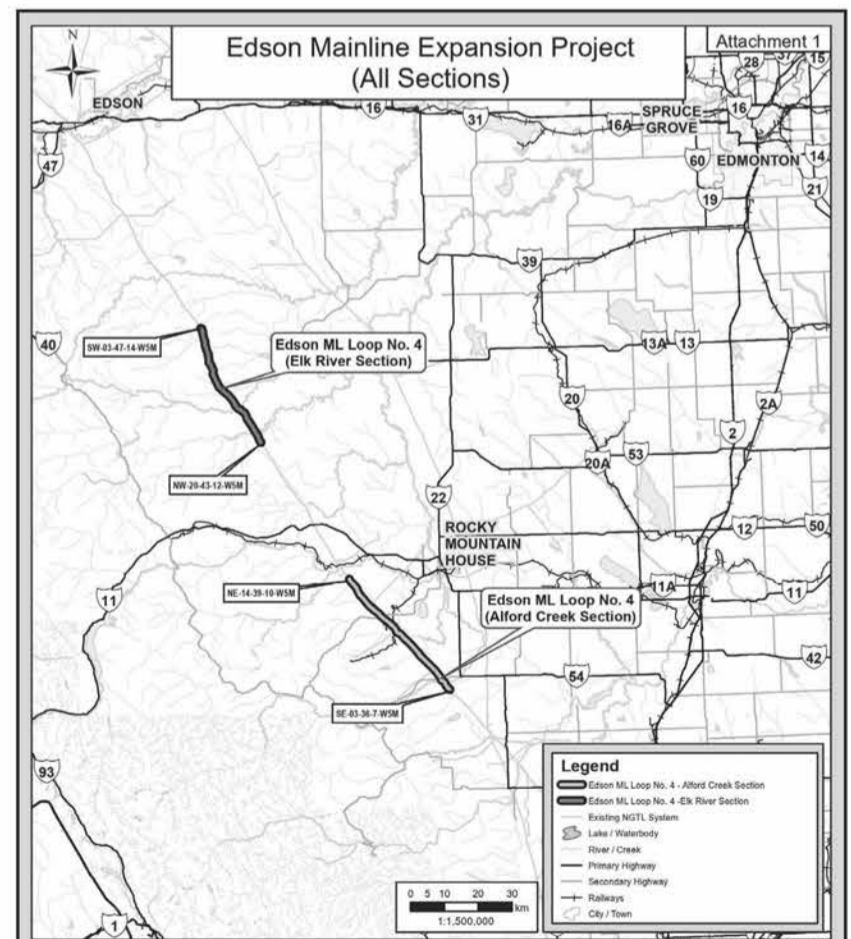

Diversifying Alberta's agriculture sector

The governments of Canada and Alberta are supporting the Alberta Hemp Alliance (AHA) with a one-time grant to establish a provincial industry association for hemp processing with more than \$300,000 over two years (2021-2023) through the Canadian Agricultural Partnership.

The grant will help AHA build capacity to fulfil its mandate as the provincial association for the hemp industry in Alberta. AHA intends to be self-sustainable beyond its first years of operation by creating revenue streams from membership fees, an industry sales levy, education and training, webinars, conferences and trade shows.

“Supporting the burgeoning hemp industry is important because it will provide producers new

market opportunities and a way to diversify their rotation with this alternative crop. From seed to straw, the opportunities to sell this crop are growing, with value added products ranging from food to biofuel to bioplastics and construction materials.” —Marie-Claude Bibeau, federal Minister of Agriculture and Agri-Food Canada

The Canadian Agricultural Partnership has also provided more than \$950,000 in grants to BioComposites Group Inc. (BCG) in the past three years to support growth in the hemp fibre industry in Alberta.


