County adds library renovation project funding request to 2030 budget deliberations

During the Yellowhead County Council meeting on Sept 27, council discussed the Edson & District Public Library's request for financial support to complete both an extension and renovation to their current library facility.

The library board requested \$538,000 in financial assistance from the county for the project. Total project budget is estimated at \$2,875,243*.

At the September 20, 2022 Governance and Priorities Committee meeting, members of the Edson & District Public Library (EDPL) presented to Council their plans to undertake both an expansion of their current library facility as well as interior renovations.

In a briefing to Council, GM Crystal McNernie with Yellowhead County stated that the proposed project would achieve: a welcoming, engaging design; increased

capacity and functionality; accessible and inclusive spaces; address safety and code compliance issues; and dedicated children and teen spaces.

Timelines indicate that the project will be tendered in quarter one of 2023, with construction beginning soon after. The library board anticipate a total project length of 12-18 months, with the facility being finished in its entirety by 2024.

To date, funding has been pursued through the library's own fundraising and reserves, provincial and federal grants, as well as through requests to both the Town of Edson and Yellowhead County Councils.

Council voted to direct Administration to include the \$538,000 request from the Edson & District Public Library for 2023 budget consideration.

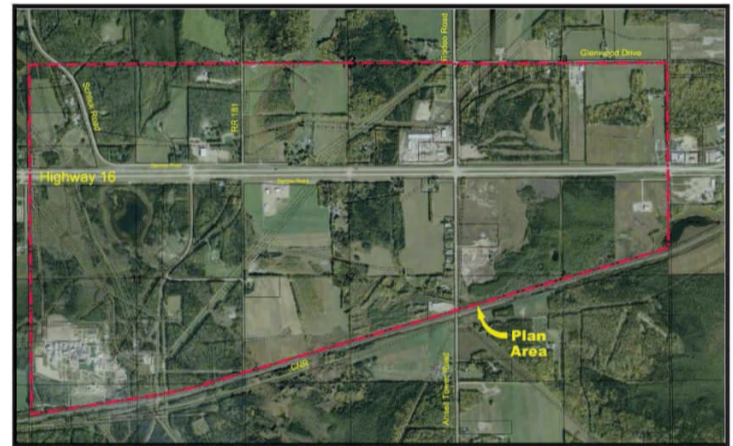

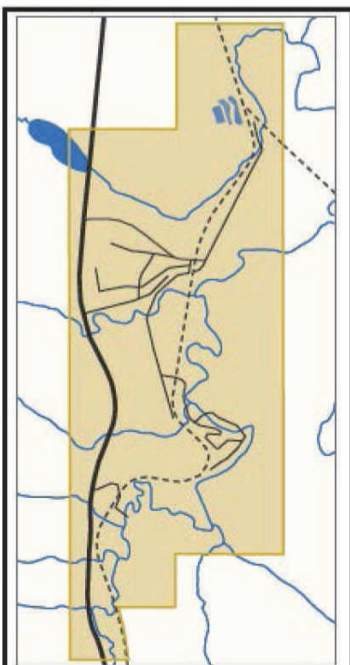

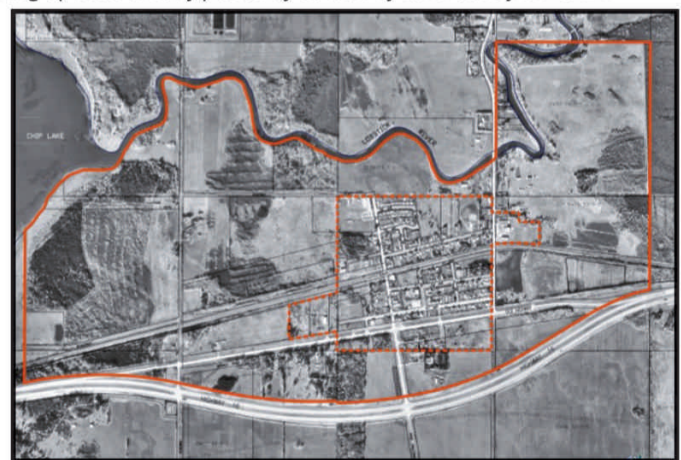

While the Conservatives oppose every affordability measure, we will remain focused on delivering for seniors."

It represents an important step forward in understanding how to most responsibly advance Alberta's hydrogen economy. I am proud of Alberta's momentum in this space – not only launching a cutting-edge road map but also being the first province in Canada to publish a comprehensive inquiry to

establish a legislative and regulatory framework for hydrogen blending across the entire province.

“Hydrogen blending has the potential to help reduce emissions and grow the clean energy sector while fuelling our homes and businesses. Our government continues to take steps to explore how to safely, reliably and cost-effectively introduce hydrogen into Alberta's natural gas system.

“In the coming months, we'll work with stakeholders to continue developing a hydrogen blending framework that provides certainty to investors and supports a cost-effective system for Albertans. In addition, we will work to clarify different organizations' responsibilities in regulating the various parts of a hydrogen blending market. This will help protect consumers and ensure companies looking to move forward with blending hydrogen and natural gas have all the information they need to proceed.

“Alberta's hydrogen sector continues to grow at an amazing pace, with more announcements of funding, pilot projects and technological advancements arising all the time. We are committed to exploring the hydrogen blending opportunity in an efficient and clear way.”

Quick facts

- Hydrogen blending is the process

where hydrogen is added to natural gas transmission and distribution systems.

- When used as a fuel source, hydrogen emits only water vapour when combusted.

- The AUC inquiry was focused on hydrogen blending at 20 per cent by volume in natural gas distribution systems, such as those used for residential and commercial utility purposes. This includes the mixed fuel's use in existing appliances such as furnaces, boilers, water heaters, gas fireplaces, stoves and laundry dryers.

- Alberta's Hydrogen Roadmap identifies hydrogen blending at 15 to 20 per cent by volume into the natural gas distribution network as an early and important market for Alberta's hydrogen ambition.

Low Emission Coal & Powering the Globe

Coal plays a major role in delivering power across the globe – it is still the world’s largest single source of electricity and will still contribute 22% in 2040. This figure is even higher in emerging markets – in South East Asia, coal will fuel 39% of electricity in 2040.

Coal has a fundamental role in providing access to baseload electricity – power that is constantly available – across the globe. Reliable, affordable, and stable energy access is a key requirement for modern life, preserved by the UN’s Sustainable Development Goals, yet more than 3.5 billion

people lack reasonably reliable access to electricity.

Reliable supplies of energy at affordable prices are critical to global development. For many countries, coal provides affordable, reliable energy. As a predominant energy source, coal has and will continue to contribute to achieving the goal of ‘energy for all’. Coal’s proven energy credentials in providing energy access are demonstrated by the 1.7 billion people who gained access to electricity for the first time between 1990 and 2010. Of these, around 93% did so through coal.

For some rural communities, renewables are the only way to enable basic energy access. To transition from basic access to the level of access required to develop

societies, enable hospitals to fully run, business and manufacturing to take place, people need to have access to grid-based electricity. Growing economies need abundant energy – electricity that is reliable and affordable to power opportunity and go further than simply mitigate the worst effects of extreme poverty. Coal can provide this whilst also supporting the penetration of renewable energy sources.

Variable renewable energy alone simply cannot provide baseload, since wind and solar will always be intermittent, as the wind and the sun are not constant. Coal power plants are a proven provider of baseload given their capacity to operate continuously. Similarly, variable renewable energy cannot provide dispatchable power – electricity that can be used on demand. As emerging economies grow, so too does their energy demand. Coal can complement renewables and, through the use of clean coal technologies, be environmentally compatible.

Canola crop options – Sell, replace or store

“Other than sales commitments already in place, a question is what to do with canola inventory,” says Neil Blue, provincial crops market analyst with Alberta Agriculture, Forestry and Rural Economic Development. “Should it be sold to take advantage of these still high prices? Should it be sold and replaced on paper to capture a potentially higher price? Should it be stored to await possibly higher prices, while taking precautions to ensure safe storage?”

An important first step in marketing is to know your product. Submit representative canola samples to a few buyers and possibly the Canadian Grain Commission under their Harvest Sample Program. Blue notes that some buyers may pay a premium on oil content above a threshold level.

One consideration is the need for cash flow to pay outstanding and upcoming expenses. An alternative to selling canola for cash flow needs

is to use the federal Advance Payments Program to borrow against crop inventory. The interest-free limit has increased from \$100,000 to \$250,000 for the 2022 and 2023 program years.

“An alternative after pricing canola is to replace some of that volume with paper positions by buying deferred futures positions or by buying call options. With an improved canola supply this year, the canola futures market has returned to a more typical carrying charge situation, where deferred futures prices are higher than nearby prices.”

For example, the May 2023 canola futures price is \$16/tonne higher than the November 2022 canola futures price.


“With the futures market in that carrying charge situation, buying deferred month futures or call options has a disadvantage. As time

passes, the carrying charge erodes. That makes it more challenging to benefit from a replacement strategy because the canola futures need to rise enough to offset the eroding carrying charge.”

Storing some canola may also be a good decision. Although most canola was harvested in dry condition, producers must pay attention to the condition of stored canola. Canola can even heat at low moisture levels, especially if binned warm.

“There are several marketing alternatives to consider for canola. Often, compromise is a good strategy, that is price some, store some, and possibly replace some on paper by using your own brokerage account or a similar strategy through a grain buyer. Remember that nobody knows for sure what the market will do,” says Blue. *-AgriNews*

L.S. Chafer, an American theologian around the turn of the last century, once wrote this small parable:

One man challenged another to an all-day wood chopping contest. The challenger worked very hard, stopping only for a brief lunch break. The other man had a leisurely lunch and took several breaks during the day. At the end of the day,

the challenger was surprised and annoyed to find that the other fellow had chopped substantially more wood than he had. "I don't get it," he said. "Every time I checked, you were taking a rest, yet you chopped more wood than I did." "But you didn't notice," said the winning woodsman, "that I was sharpening my axe when I sat down to rest."

One of the lessons we saw people learn while working from home during the pandemic is how
