Town Council debates mask bylaw but province weighs in with mask mandate

Following concerns over a large increase in COVID-19 cases in the Edson zone, Edson Town Council considered

implementing a mandatory mask bylaw during a Special Council Meeting on September

The bylaw was first presented to the Emergency Management

Advisory Committee (EMAC) on September 1, where members provided their general support for the bylaw and the risk level indicators that would inform the enactment and

rescission of its provisions.

As with any new bylaw, three readings can be given during the meeting it is presented, however the third reading must

be unanimous for the bylaw to pass. In the event that the third reading is not unanimous, the bylaw will come back to a future meeting where it will only require majority vote to pass.

During the presentation of Bylaw 2266 (the Mandatory Facial Covering Bylaw), it was explained that the bylaw would require the use of facial coverings for all individuals over the age of two in all indoor or substantially enclosed public places or in any public transportation vehicle. Administration explained that in the week prior to the special meeting, the Edson zone had seen a 300% increase of cases and that, at the time, was the 11th highest area in the province per 100k.

The bylaw would have come with a \$100 fine for a first offense to "Fail to wear facial covering where required," and \$250 for subsequent offenses. There would have also been a \$250 fine for a first offense to "Interfere with a person in the exercise or performance of the person's powers pursuant to this bylaw," and \$500 for subsequent offenses. Several reasonable exemptions for mask-wearing were also included.

Before opening discussion, Mayor Kevin Zahara noted that he and Council had all received "various correspondence... both for and against" regarding the potential bylaw.

Councillor Krystal Baier shared her feelings against the bylaw and offered other suggestions. "We could unite and beg our businesses and beg our residents to work together to reduce in-person gatherings, go back to limited cohorts, recommend wearing masks... reduce capacity at our businesses back to 25%," she suggested as an alternative to a mandate, noting that masks "create a lot of polarization and division in our community."

Baier expressed her frustration with the lack of "leadership and guidance" from the Alberta

government on the matter. She also noted that if people were against vaccinations and masking that a mask mandate wouldn't make them put on a mask, and that their refusal is difficult for businesses to enforce.

Councillor Troy Sorenson also spoke about the issue of the province downloading issues onto municipalities and spoke about why he felt the bylaw shouldn't be imposed. "In short, people that are worried about COVID are already vaccinated or are already wearing masks in public. People that are not worried about COVID will ignore this unenforceable bylaw and will never wear a mask. This bylaw is literally the definition of a band-aid solution on a much bigger problem of vaccination rates and I am unwilling to ask our residents to suffer any longer," Sorenson said.

Councillor Gean Chouinard said he was "struggling" with the decision and agreed that it was a provincial issue. He said he would make up his mind as the vote came up after hearing from the rest of Council.

Councillor Trevor Bevan also felt on the fence. "I received a lot of emails and texts and everything else. Most of them were for, some against. After listening to them talk, the one big thing they said is, you know, if we don't do it and the government starts shutting down businesses, some of our businesses will never come back," he said. "I don't want to see any more businesses shut down, I don't want to see any of my friends going to the hospital, or anybody at all."

Councillor Janet Wilkinson thanked everyone who had reached out to discuss the issue. She spoke about the deaths of Albertans and said, "If we can prevent any illness or death that is my job to support the mask bylaw." She added that she hoped

Councillor Jacqui Currie expressed her support for the bylaw. "Health is not a municipal mandate, but unfortunately our provincial government has



chosen not to be leaders," she said before adding that, "Our hospital is already at capacity, we are already vulnerable."

"The vaccine is obviously the best protection, but unfortunately we have 52.9% of our population not fully vaccinated which means 52.9% of our population is highly vulnerable," Currie said. "To me, masks are not an opinion conversation. Masks are a public health measure."

Currie acknowledged that masks "are only one layer of protection" and said, "There's not a lot that we can do as leaders, but we can implement that one extra layer."

Zahara spoke up next. "I really struggle with this because I don't want to put a mask bylaw in place. I don't feel like we should have to. It would be great if we could just ask people to do the right thing and hope that they do. If we would get mass amounts of Edsonites that would do so, we wouldn't need these sorts of things," he said. "Unfortunately, when you make those requests it doesn't always happen until you put a law in place."

Mayor Zahara asked all residents listening to the meeting to take appropriate precautions and consider getting vaccinated. "That is our best way forward through this. I don't know how effective this mask is, I really don't. I'm concerned if we do this that we are going to create division in the community," he said.

Zahara noted that he wanted to vote in favor of first and second reading, but not to move to third reading which would push the matter to the September 7 meeting, hopefully giving residents a chance to slow the spread on their own.

The bylaw passed first and second readings at a vote of 5-2 but failed to move to third reading. It was scheduled to be brought back to their next regular Council Meeting on September 7.

However, on September 3 the Alberta government seemed to finally hear the frustration regarding lack of leadership on the matter and introduced a province-wide mask mandate in indoor public places and workspaces to help mitigate the spread of COVID-19, essentially negating the need for a mask mandate to be introduced at a local level.

"Since our special meeting, the Province has announced a provincial masking mandate which pretty much negates our bylaw so we can either approve this one or we can defeat it," said Zahara at the September 7 meeting. "I would suggest we defeat it but I'll leave that to Council to decide."

Councillor Currie said, "I will support defeating this because the provincial government has stepped up to the plate... Just hopefully though that it doesn't become an issue and the province keeps it in place until we have control of this."

Zahara noted that, as of September 7, Edson had

150 active cases. "That's more than the city of St. Albert, for some perspective," he added.

Council voted to defeat the motion. Therefore, no local mask mandate has been implemented, however, provincial mask mandate laws still apply.



On-again, off-again restrictions need to end...

Alberta Health now requires liquor service to stop at 10pm, a restriction that will most



certainly hurt many small businesses.

Covid-19 cases have been growing exponentially, mostly among the unvaccinated, driven by the more infectious Delta variant. Surgeries have been delayed, patients in some regions have been transferred, and some emergency room beds have been temporarily closed.

Last week the Alberta government announced that restaurants, cafes, bars, pubs and nightclubs, as well as (most) events, will be required to end alcohol service at 10pm in order to slow transmission of Covid-19.

This action appears to be in flagrant disregard of Premier Jason Kenney's vow not to shut down small business operations again.

This spring, Premier Jason Kenney stated, "We made a stupid mistake with restrictions that tilted the playing field toward big box stores by keeping them open, while closing our small businesses. For that, I apologize." He added that, with carefully targeted measures to slow the spread, "We won't make that mistake again".

Again, addressing the UCP faithful at the party's AGM, Kenney stated, "I

give my absolute commitment to that sector [restaurants and bars] that is struggling, that

barring some absolute catastrophe, which we do not see, there is no likelihood of restrictions on their ability to operate like we had in the spring...'

According to Kenney, back in the height of the pandemic last October only about 3% of positive tests for Covid-19 were tied to exposure in the entire hospitality sector.

Yet here we are, only months later with over 70% of eligible Albertans fully vaccinated —and liquor service businesses have been singled out, despite their efforts to make their spaces as safe as possible.

Many of these businesses have worked hard to bring back staff, only to face laying them off again.

And when the Alberta government gave several events an exemption to the 10pm liquor curfew —it is no wonder why the industry is feeling unfairly targeted.

The government's first response to rising Covid-19 cases should not be shutting down small business operations. This knee-jerk reaction of on-again, off-again business restrictions needs to end if these businesses are to survive.

Town Council Highlights

(Sept 7, 2021) As the municipal election draws near Town Council focused on cleaning up wording in some of the Land Use and Bylaws including aligning the Subdivision and Development Appeals regulation with the most current amendments to the Municipal Government Act.

A public hearing for October 5, 2021 was set regarding proposed changes to Bylaw 2263 which would allow Hotels/Motels to be established within the C-2 zoning area in order to facilitate the development of a service establishment at 5904 3 Avenue.

A second public hearing for October 5th was set to address how the Town manages billboard approvals. The proposed amendment would simplify the section of the Land Use Bylaw

which deals with billboard approvals and, as proposed, would remove the five-year renewal requirement.

A tax recovery auction for properties who have been remiss in paying their property taxes has been set for November 16, 2021. The list was sent to Land titles in March of 2020 and the auction would affect properties which have been in arrears since 2019 or previous.

Council adopted, in principle, the Vision Park Revitalization plan as presented on August 10th. Councillor Currie clarified that the plan was adopted in principle and would only move forward as budgetary constraints allow.

Council voted in favour of cancelling the Committee of the Whole meetings scheduled for September 18 and October 12 due to the upcoming municipal election to be held on October 18.

'Refusal to Mandate Masking in Schools Is Asinine': ATA

ATA president Jason Schilling has issued the following statement in response to the decision to exempt schools from a provincewide masking mandate.

"Tightly gathered indoor groups of 30-plus unvaccinated, unmasked people will continue to occur with the blessing of government.

"Alberta's elementary students are crammed into inadequately ventilated spaces, and the government is shirking its responsibility to offer the bare minimum protection for those who cannot be vaccinated and their families.

"The government is recommending that all unvaccinated persons limit indoor social gatherings to a maximum of 10 people and requiring all vaccinated persons to mask in public spaces, yet schools remain exempted. This is asinine.

"The government lacks the courage required to do the right thing and is leaving school boards to clean up the mess and take the blame. In fact, government MLAs and other officials have inflamed tensions recently by suggesting publicly that school board masking mandates run contrary to Dr Hinshaw's advice. This is not helpful.

"An immediate adjustment must be announced to take effect across the province on Tuesday. Mandatory masking in all schools and a return of contact tracing for students in elementary classrooms must be implemented." —Jason Schilling, ATA President





This week, we saw some small but angry protests outside a handful of our healthcare facilities.

I am proud to live in a country that supports the right to peaceful protest, and I also support the right for people to voice their opinions.

However, I was very frustrated that some of those protests turned into personal attacks on our physicians and staff.

I am aware of instances where AHS employees were yelled at, and subjected to harassment. Some did not feel safe walking to and from their workplace.

We are also aware of some patients and families who were obstructed as they entered facilities to receive care.

That is uncalled for and extremely unsettling.

Our healthcare workers are doing all they can to care for Albertans, and they deserve the utmost respect and support.

If you oppose masking, vaccinations, or any other measures taken to prevent COVID-19 transmission, that is your right. But to target healthcare workers with anger and vitriol is not acceptable, particularly now.

It has been a long pandemic, our physicians and staff are under a lot of stress. and their work is exhausting. Many are feeling burned out and impacts are immeasurable. They are stepping up once again, as we face a fourth wave exacerbated by the highly transmissible and virulent Delta variant.

Now more than ever, our physicians and frontline teams need your support.

We have certainly heard from many, many Albertans who have reached out to thank healthcare workers, and we are always grateful for that.

Our physicians and staff – and our hospitals and healthcare facilities – are very busy and the pressure is enormous. We should be there for them, just as they are there for us.

Please do your part to help. Get immunized as quickly as you can, consider wearing a mask in public, indoor settings where physical distancing is not possible, and please, stay home when sick.

Minister of Community & Social Services, in Jasper and Edson. We toured the Edson ShelterPod Project with Edson Mayor Kevin Zahara, and other community stakeholders. Productive, thought-provoking meetings were held with representatives from Jasper Employment Centre, FCSS Jasper, Edson and Yellowhead County, Reflections Edson, and McMann Youth, Family and Community Services

Big news for Edson and surrounding areas, Westmoreland Coal announced their reopening on August 9. Their restart will bring the hiring of 300 highly skilled local employees. The mine has been in care and maintenance since June 2020 due to severe constraints related to COVID-19 pandemic. According to Steve Love, General Manager of Coal Valley, reopening the mine will also add approximately \$30 million a year to the local wage base, at least \$3 million in taxes and royalties to the Province, and \$60 million a year in economic activity dispersed within multiple sectors associated with the mine's purchases of supplies and services.

The Coal Valley Mine is a 20,660 Ha. surface mine located in West Central Alberta south of the Town of Edson in the Foothills of Alberta. The mine exports bituminous coal to customers in Japan and Korea as well as some domestic coal.

Provincial Government Extends Public Health Measures & Announces Back to School Plan

Chief Medical Officer of Health, Dr. Deena Hinshaw, has announced changes to the province's public health measures. Isolation, testing, and public transit masking rules that were supposed to lift on August 16th will remain in place until at least September 27th. No new measures were announced, and the province's data has been publicly released.

Alberta's back-to-school plan follows along the same lines as other provincial health measures. All precautions will be



proportionate to the overall risk level. School authorities will have the

ability to implement further health measures for their own unique situation. Additionally, school authorities are expected to respect and accommodate students' and parents' personal choices. As roughly only half of children ages 12-18 years old are immunized, vaccines will be offered in temporary school clinics to students and staff starting September 7th.

Rodeo Season!

August in Alberta certainly means long summer nights farming and Rodeos! After a short hiatus, the circuit is back in full swing. I celebrated the 40th Annual Medicine Lodge Rodeo, finally meeting Susan Longmore, the tireless organizer of this very popular family event. The annual Whitecourt Woodlands Rodeo enjoyed a successful event, with blue skies and sunshine. When attending with my family my daughter was enthralled with the barrel racers. We enjoyed a fabulous evening and the only problem I have now is telling my daughter she cannot have her own pony!

Funding Rural Infrastructure

Alberta's economy relies heavily on safe rural transportation, and this capital investment will go a long way in helping rural municipalities and developing businesses. Alberta's government has announced new funding to support rural infrastructure across the province. The Strategic Transportation Infrastructure Program (STIP), an investment of \$31.5 million, will go towards a total of 48 projects, which include upgrades to roadways, bridges, and culverts in the places that need them the most. West Yellowhead has received \$337,500 for a bridge culvert replacement in Woodlands County.

This summer it has been great getting out to events and meeting constituents, spending time sharing ideas and hearing concerns. I appreciate the many people, places and activities that make West Yellowhead unique, and one of the best places to live, work and raise a family. It is my honour to serve as your MLA.



As her children, we feel we can agree that our mother Lucy was an ORIGINAL. She left this world having lead a full and active life. Her loves, interests, and abilities were varied and endless. Her curiosity, compassion, and love of conversation meant that no one near her was a stranger for long.

From family to animals, friends, and community, Lucy found time and energy for all

Although her parents, Max and Bessie lived at Miller Ranch, south of Carrot Creek, Lucy was born on May 14, 1937, at the St. Joseph Hospital in Edson, Alberta. For Lucy, her early life at "the Ranch" was paradise.

The family moved to Niton in October 1946, after her parents bought the store from Sam Robinson. For Lucy, the adjustments to regular school, the loss of animals left behind, and finally the sale of "the Ranch" were bitter pills to swallow. However, in December 1947, Elizabeth Julia, or sister Beth, was born. Lucy remembered being excited that the baby had finally come.

During this time, with the store, CN activities, and the Niton Community Society, Niton (believe it or not) was a happening place! Dances, plays, and attending movies, because her dad had a vehicle, were some of Lucy's options. Her companions were often members of the McPhee family, cousin Maureen and Mildred Wiseman.

In 1956, Lucy was a member of the first graduating class of Niton Central School. She married Jack Robinson, oldest son of Sam and Valma Robinson, in November of that year. As a young couple, they took up residence in Carrot Creek on the Robinson homestead. During their time in Carrot Creek, their four children Leisa, Coleman, Julia, and Dean were born. The family moved to Niton in 1964. Jack had work truck driving and Lucy started helping her dad in the store.

Those years were busy for Lucy with four children, a store, a farm, and a husband who worked away in the north. There were music lessons, talent shows, hockey and school sport events, fairs, parades, horse shows, and rodeos. Lucy even managed to decorate numerous wedding cakes for young couples and act in the annual community plays. She often remembered those enjoyable times, such as when Kenny Lind helped construct and decorate a challenging wedding cake.

In 1976, Lucy bought the Evansburg Ceramic Shop and moved it into the store building at Niton. She was grateful to Ray Blackburn, Gordon Hanson, Doris Currie, Doreen and Harold McLean and many more who helped her get her new business up and running. As a life-long learner, Lucy attended ceramic technique lessons in Edmonton to stay a lesson or two ahead of her students. She enjoyed the ceramic business very much and was very well supported by the surrounding communities.

In 1980, Lucy moved to Likely, BC, where she and Clint Coleman spent twenty years as active members of the gold mining community. She was soon a director of the Cariboo Mining Association, President of the Likely Chamber of Commerce, as well as host and guide for any wayward miner or tourist who decided to take an interest or risk in gold mining. However, she enjoyed family times and daily visits with friends in her home and at the local café.


