Four of six candidates show for Yellowhead Federal Election Forum

The Edson & District Chamber of Commerce hosted a virtual 2021 Yellowhead Federal Election Forum on September 9.

All six candidates were invited to participate in the forum, however only four chose to attend. Those four were Gordon Francey of the Veterans Coalition Part of Canada, Michael Manchen of the People's Party of Canada, Todd Muir of the Maverick Party, and current MP Gerald Soroka of the Conservative Party of Canada.

Sheila Schumacher of the Liberal Party of Canada and Guillame Roy of the New Democratic Party did not attend.

The forum was held on Zoom and was moderated by local teacher and prominent community member Peter Taylor.

Taylor started the forum by explaining that each candidate would get a chance to make a two-minute opening statement, and then would participate in a question-and-answer period where members of the public could ask questions via the Zoom meeting. Finally, they'd get a 90-second closing statement. Each portion's order of candidate response would be

determined by random draw. Below are a few of the questions asked during the forum and the candidates' responses.

What is the most important issue in Yellowhead today? – asked by Ed Moore

Todd Muir: Oh, that's going to be tough to answer in one minute. Big riding, there's lots of different concerns but I'd say all of our concerns revolve around fairness to the West. Getting our natural resources to markets, getting fair market for that, and equalization payments. All of these are systematic problems that are caused or are a result of problems with the Federal government. So the Maverick Party advocates for fixing all these and we have a plan to fix the fairness for the West issue with our 5-point Twin Track approach to Constitutional changes and our proposed elimination of the equalization formula completely to make it actually work how it was intended.

Michael Manchen: Freedom and prosperity. The number one problem in the Yellowhead region right now is the Federal government. It is the one, single thing holding us back from moving forward at a very rapid pace. Taking

our freedoms away and, you know, how many different bills have been written up just in the last couple of years alone? Many of them you haven't even heard of. And they're just restricting us and restricting us and restricting us. C-16 was just written the other day, we can no longer do anything in industry without talking to the Indigenous first. And why they'd come up with something like that is strictly to restrict any pipelines from going through in the future. Yeah, the Federal government is the number one problem and that's why we're here. We're going to change it right out and start with something fresh.

Gordon Francey: I would say forestry, energy development, and farming are the major issues here. We need to eliminate the carbon tax and make it easier for the farmers. We need to rebuild the energy industry because it produces the funds necessary to research into alternative fuels and energy sources. The forestry industry, we need proper forestry management. All of these forest fires are a result of improper forest management. And I agree with Todd and both Michael that it's a financial issue stemming from Ottawa and the bills they're putting

through that are damaging the Albertans way of life, period.

Gerald Soroka: Yes, probably the biggest thing is jobs and the economy for this area. We have been stifled quite a bit for some time, a lot to deal with. You know, like I mentioned earlier, Bill C-48 the tanker ban, Bill C-69 the assessment review. There's been several prime examples of pipelines that are starting to get built again which is good to hear, you know Trans Mountain is going, that's great for the economy. The NOVA GasLink will be starting here this coming year so that's a good start. But we've been stifled quite a bit, but through the Alberta government and the Federal government, with our plan, would be to start looking at natural gas. We know that natural gas is a huge opportunity for us in Yellowhead so there's great opportunities for job creation and once you start spinning off jobs, there's a lot of side effects that are being taken care of as well. The other issue that we really need to start looking at is our mental health in the region. So because we have a good economy and strong jobs and people working again, it will also assist with our mental health in this area as well.

What are the plans for internet service and the ridiculous costs? – asked by Carrie Austman

Todd Muir: Yeah, we pay some of the highest cell phone costs, I'm sure our internet costs are equally high. Again, one of the issues here in Alberta is that we have a large rural population. We're the only province that actually spreads out to the north so we pay a disproportionate amount of that. We are a free market party though, we would support equal and fair access to the internet, working with industry to develop that. Again, if we are allowed to keep more of our money here in Alberta, it's something that our provincial government could actually focus on our northern and rural communities to do this. But unfortunately a lot of our equalization money gets sent to other provinces so we don't have the resources to look after our people on this and other matters.

Gordon Francey: We're not competitive at all in Canada. The big companies basically rule. There are technologies currently available that are not available to the public, that would alleviate this to a great degree. We would like to see them implemented and put in place. And it can be done relatively quickly at a relatively reasonable price. And this would make us not only very productive but very cost efficient as well.

Gerald Soroka: First, we have a 4-point plan, we have accountability, we'll hold big telecom service providers accountable for the anti-competitive behaviour and practices that hurt consumers. Then we'll have competition, we'll promote competition by allowing foreign telecommunication companies to come into Canada as long as they're going to reciprocate with Canadian companies in their country. Access – we're going to build digital infrastructure and connect all of

Canada to high-speed internet by 2025 as well as then we'll invest and promote investment in community communication facilities by local and regional communities and businesses. This will help reduce local and regional dependence on national telecommunication giants.

Michael Manchen: Well, anytime you involve the Federal government it's going to cost a lot more money than it needs to. I strongly recommend check out Starlink. It's done by SpaceX, it's \$130/month in Canada. I know that the Federal government has already negotiated a few areas of Indigenous towns in the northern parts of Canada with Starlink, and probably got a better deal, and that's the way I would go and you can have high-speed internet anywhere on planet Earth between mountains and everything else. And there's no infrastructure that we need to install whatsoever and people can compete head-to-head against them if they want to but the Federal government doesn't need to be involved in something they don't need to be involved in.

None of the parties have yet mentioned how they will benefit farmers. What can we expect from any of them? – asked by Dallas Hayward

Gerald Soroka: Actually that's another area that we need to definitely get into. We need to start looking at new markets for our livestock, grain, oilseeds, as well as with the free trade that we have against other nations and that, because we have great producers right here in Canada but we've been stifled by a lot with free trade and unfortunately it's this government that we currently have that has hurt relations in other countries. Or

they've made poor deals when it came to free trade. So we need to make sure that those markets are available to our producers. At close at hand though, this year because of the drought situations, we need to

make sure there's the AgriRecovery plan available to our farmers. We need to make sure AgriInvest is also available to our farmers. The transportation of feed as well as

livestock is another factor that we would like to see implemented to subsidize farmers from getting feed into this area. The drought measures definitely need to be looked at.

Todd Muir: One of the big things the Maverick party supports is the creation of energy corridors and pipelines including the Energy X pipeline, we support twinning of the rail tracks and other ways that get our farmers' goods to market. You know, to get them out, we currently see situations from time-to-time when that's blocked because so much oil is going by rail. We also, unlike the Conservatives, we do not support – or, we're not sure where the Conservatives stand on the gun control measures that were put in by Erin O'Toole and I'm not sure if our MP would be allowed to speak on this but we believe in gun rights and property rights for farmers to protect their own property from crimes, from criminal elements that might take advantage of them being so far from police.

Gordon Francey: We would eliminate the carbon tax which is impacting the farmers greatly at this

time. Getting their crops to market is a big thing and giving them more say in who they sell to and how they sell. Remove government as much as possible from it. The government should only be there to guide, not to order them what to do. We believe in property rights completely. We would like to go back to the old method of royalties for farmers who have their property being developed for oil or gas. It's basically whatever the farmers want, whatever they feel they need, we would be willing to sit down to discuss it with them to give it to them.

Michael Manchen: So, talking with real farmers, when we abolished the Alberta Wheat Pool, for example, they were able to get their product to market on their own, rather than being dictated to where it was going to go to and they ended socialism for farming. The price for a quarter-section of land went from \$50,000 a quarter-section to \$500,000 in a period of 15 years. So government never is helpful. The only thing we can do right now is eliminate the carbon tax because if there's a wet year and they've got to dry all their grain, holy hell that's expensive. The

amount of fuel that they have to burn is astronomical. Another thing we would not do is, like the present government did this year and they, because it's election year, paid for the farmers' crop insurance, 30% of this year to try to buy their votes. So that means they've got to increase their carbon tax so they, really, it's a vicious loop. So just get out of their way, get rid of the carbon tax, and they'll do well.

Edson Eagles preparing for inaugural season

New Junior A hockey team the Edson Eagles are getting ready to hit the ice in Edson for their 2021/22 hockey season.

The Edson Eagles will be playing in the Greater Metro Junior A Hockey League (GMHL), which has been around for 17 years and is Canadian owned and operated. The league has 30 teams across Canada.

Currently, the team has 15 players signed and will be filling out the rest of their roster during their upcoming Main Camp tryouts. The team will hold 23-26 players for the majority of the season.

So far, signings have included players from Alberta, BC, Saskatchewan, Manitoba, Ontario, Quebec, and the USA, and they even have a player from the Czech Republic.

When asked what he is most looking forward to about the start of the season, Head Coach/GM Ryder Prue said, "Getting a quick start and picking up some wins, as well as getting our players volunteering in the community and making a change for the better. Being positive role models for the youth of Edson and giving the people in this Town something to look forward to doing on the weekends!"

Prue said that it is important for him that his team be "someone the youth can look up to." The Eagles have already started being a presence for the community through volunteering at the Edson Road Hockey Rumble on September 11 in the parking lot at Repsol Place.

Seven team members participated, cooking burgers and hot dogs and working the food table throughout

the day. They also played against the youth during the tournament. "Our players all loved it and were excited to be a part of the community and help out with the youth," said Prue. "The group we volunteered for was very happy to have us there and made for a great day of family fun and hockey."

The team will also be volunteering at the Edson Open Horse Show on September 18, which will be held out at the Yellowhead Ag Society (Edson Rodeo Grounds).

Prue said that his goal this season is "to develop these young men on and off the ice into better hockey players and better human beings in general." He also hopes to help improve the players and help them move to the next level of hockey, whether that be collegiate or professional.

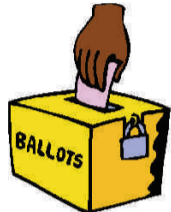

A little directional clarity please...

In a startling revelation, Dr. Deena Hinshaw, Alberta's chief medical officer of

Hinshaw referenced data from neighbouring B.C. Since B.C.'s

health admitted the province's lifting of restrictions earlier this summer was the wrong approach.

Hinshaw was speaking to Alberta physicians during an online address to the province's Primary Care Networks on September 13.

With ICU admissions surpassing 218, Alberta is now in a crisis situation. Hinshaw admitted the course of the fourth wave can be blamed on the province's decision to lift all pandemic restrictions at the start of July.

"I think if we look at the experiences of all the different provinces across the country, those that have kept the base level restrictions—to manage the interactions and close contacts—are the ones that are not seeing a significant impact," Hinshaw said. Provinces that removed restrictions are experiencing a large increase of COVID-19 cases with their health care systems reaching critical levels.

Hinshaw also confirmed that the health care system is seeing the highest amount of community transmission since the start of the pandemic. Hinshaw admitted that had she known how bad the fourth wave would be, the plan to remove contact tracing would not have come into effect so early.

Regarding vaccine passports,

announcement two weeks ago, there has been an increase in vaccinations among the younger population. This demonstrates that requiring vaccination to participate in some activities has encouraged immunization uptake.

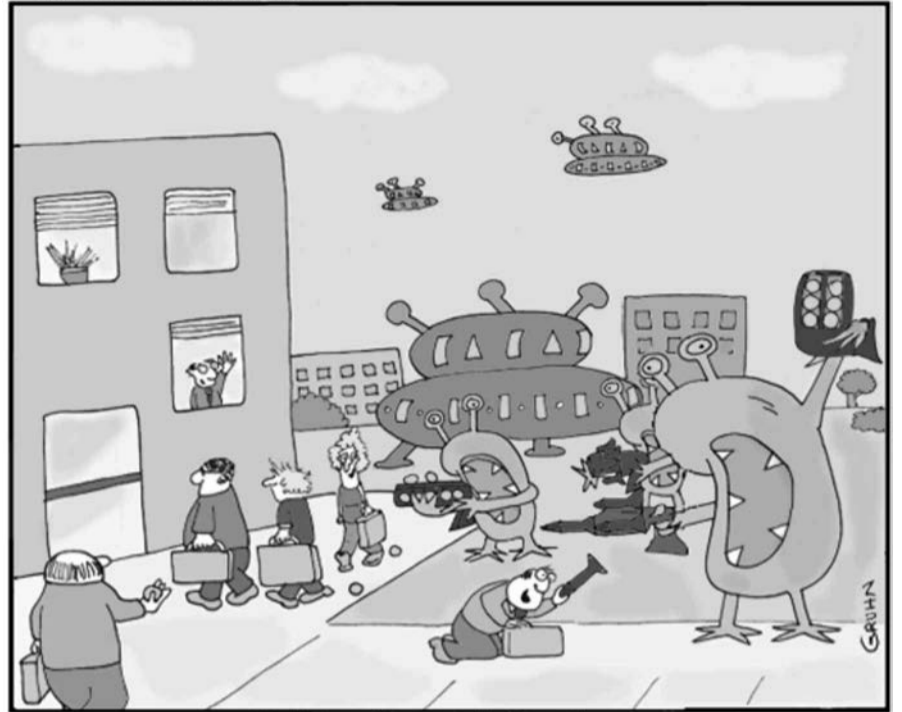
In a second startling announcement, despite Premier Kenney repeatedly stating that Alberta will not be following other provinces in implementing a vaccine passport program, Kenney announced on September 15 that is exactly what he'll be implementing effective Sept. 20.

Kenney said the pandemic in Alberta is currently a "crisis of the unvaccinated". Adding that we "are facing an emergency that requires immediate action". About 90 per cent of COVID-19 patients in hospitals are unvaccinated.

This completely preventable situation brings an old TV commercial to mind. A mobile GPS navigation device keeps repeating "recalculating" as the car drives off the edge of a cliff—the time for action had long past.

The lives and livelihoods of everyone are at stake—vaccinated or unvaccinated. So, let's hope this indecisive flip-flopping, back-peddling, and buck-passing is over and province develops a better sense of timing and direction soon. (see page 12)

County updates speed limits policy

At their August Governance and Priorities Meeting, Yellowhead County Council heard a request from residents on the East Crossing Road (Twp Rd 534) to have their speed limits lowered.

The residents had genuine safety concerns about the speed that many motorists were driving when using the road and asked the County to lower the limit from 80km/hr to 60km/hr.

At that meeting, Council asked Administration to take a look at their current speed limit policy and bring back a revised policy that would better define the criteria that determines when the County would lower the speed limits on its roadways.

Administration reviewed Policy 3200.19 to Set or Lower Speed Limits and brought back a revised version to the September 14 Council Meeting. Section 4 of the policy was updated to include the criteria for the lowering of speed limits on County roadways.

Section 4 reads:

“Requests for Speed Zone reduction changes will be considered if:

a) the density of residences along the section of road is more than six (6) residential properties per half mile of road.

b) the traffic count is more than 300 vehicles per day.

c) the flow of traffic is not adversely affected (determined at the sole discretion of the County).”

Director of Infrastructure and Planning Services Don O’Quinn explained that there are no financial impacts to the County to make these changes at this time.

Councillor Anthony Giezen said, “I would support this policy change. I think it’s good. I really like that it’s the request, it’s not an automatic. That’s important, in my opinion.”

Councillor Wade Williams asked O’Quinn how many roads the policy change would affect, but O’Quinn explained that without a traffic count he would not be able to answer that question at this time.

Williams also asked if the policy would work for the East Crossing Road residents’ request. O’Quinn explained that, under the revised policy, their request does fit the criteria.

O’Quinn also explained that this policy sets the criteria to revise the speed limits bylaw when requests come in, so once the policy is put in place then the bylaw would need to be updated to reflect the change in speed limit for any approved requests.

Council voted to adopt the revised policy. Because the East Crossing Road residents’ request fits the criteria, the bylaw to enforce a lowered speed limit on that road will be brought back to a future meeting for Council consideration.

Board meetings will occur quarterly on Mondays at 9:30 AM at the county office in Edson.

HERITAGE ADVISORY BOARD

This five member board provides advice to council with respect to the development and maintenance of a heritage program. The board will advise council on the development of policy, budget, short and long term strategic planning and guidelines for funding projects, museums, community groups, businesses and individuals. This Board meets at the Wildwood county office at 9:30 AM on the 2nd Wednesday of the month, 4 times a year.

AGRICULTURAL SERVICES BOARD

New vaccine requirements and COVID-19 measures in Alberta

Provincial release: September 15, 2021

Alberta has declared a state of public health emergency and will implement new health measures to expand capacity, increase vaccination rates and reduce transmission of COVID-19.

New temporary health measures to help slow the spread of COVID-19 will apply provincially. This includes new restrictions on restaurants, indoor gatherings, weddings and funerals, retail, entertainment venues, and indoor sport and fitness beginning Sept. 20. Measures in workplaces, indoor private gatherings, places of worship, schools and children's activities, as well as mandatory masking and physical distancing in all indoor public spaces begin Sept. 16.

Starting Sept. 20, businesses or event organizers who choose to implement a program checking patrons for government-issued proof of vaccination or a recent negative privately purchased COVID-19 test will be able to have an exemption to restrictions. If a business or service chooses not to require proof of vaccination, they will be required to adhere to the new health measures.

"We are taking necessary and critical steps to prevent our health system from being overwhelmed and once again slow the spread of COVID-19 in Alberta. These steps are not easy for anyone, but with COVID-19 hospitalizations continuing to rise, particularly amongst the unvaccinated, we have no choice but to implement the proof of vaccination measures and temporary restrictions. We have overcome past COVID-19 waves and we will once again. I strongly urge anyone who has not yet been vaccinated to do so immediately. Please protect yourself, your loved ones and your community." - Jason Kenney, Premier

New public health measures provincially - for a complete list of restrictions go to <https://www.alberta.ca/covid-19-public-health-actions.aspx>

The following measures will take effect on Sept. 16:

Workplaces:
Mandatory work-from-home measures are in place unless the employer has determined a physical presence is required for operational effectiveness.

Private social gatherings:
Indoor private gatherings for vaccine-eligible, fully vaccinated individuals are limited to a single household plus one other household to a maximum of 10 people, with no restrictions on children under the age of 12.

Attendance at any indoor private social gathering is not permitted for vaccine-eligible individuals who are unvaccinated.

Outdoor private social gatherings are permitted to a maximum of 200 people, with two-metre physical distancing maintained at all times.

Places of worship:
Places of worship must limit attendance to one-third fire code capacity.

Face masks will be mandatory and there must be two-metre physical distancing between households or two close contacts for those living alone.

Outdoor events and facilities with no indoor portion (excluding washrooms):

No attendance restrictions, however two-metre physical distancing must be in place.

Schools (K-12):
Mandatory masking for students in grades 4 and up, plus staff and teachers in all grades. Schools that can implement an alternate COVID safety plan can be exempted from mandatory masking.

Elementary schools are to implement class cohorting.

Children's sport/performance/recreation (extracurricular sports, performance, recreation and special interest):

Indoor activities are permitted, with requirements for two-metre physical distancing and masking where possible, and symptom screening for participants.

Youth aged 18 and under are not required to mask or maintain physical distancing during a physical activity, such as a team sport.

Spectator attendance is limited to one-third fire code capacity. Attendees must be masked and ensure physical distancing between different households or an individual who lives alone and their two close contacts.

There are no restrictions on outdoor activities.

Restaurants:
Outdoor dining only with a maximum of six individuals per table (one household or two close contacts for those living alone).

Liquor sales and consumption restrictions (10 p.m. sales and 11 p.m. consumption) apply.

Restaurants are eligible to implement the Restrictions Exemption Program.

Retail, entertainment and recreation facilities (includes any indoor venues, libraries, conferences, rental spaces, concerts, nightclubs, casinos and similar):

Attendance is limited to one-third fire code capacity and attendees are only permitted to attend with their household or two close contacts for those living alone. Attendees must be masked and have two-metre physical distancing between households.

These facilities are eligible to implement the Restrictions Exemption Program.

Adult (over 18 years old) sport, fitness, performance, and recreation:

Indoor activities:
No indoor group classes or activities are permitted.

One-on-one training or individual workouts are permitted but three-metre physical distancing is required.

No contact between players; indoor competitions are paused except where vaccine exemptions have been granted.

These facilities and programs are eligible to implement the Restrictions Exemption Program. Specific exemptions may also be

granted on a case-by-case basis.

There are no restrictions on outdoor activities.

Restrictions Exemption Program
Starting Sept. 20, vaccine-eligible individuals will be required to provide government-issued proof of immunization or a negative privately paid COVID-19 test from within the previous 72 hours to access a variety of participating social, recreational and discretionary events and businesses throughout the province.

To enter certain spaces that are participating in the program, including restaurants, bars and indoor organized events, people aged 12 and older will be required to show their proof of vaccination or a negative recent test result.

Businesses that implement the Restrictions Exemption Program would operate as usual, provided they are serving only people who have proof of immunization or who have a recent privately paid negative test, as per the requirements in place. This means they could immediately and without restriction serve any individual eligible for vaccination who:

Has proof of double vaccination (note that for a transitional

period between Sept. 20 and Oct. 25, proof of a single dose would be considered acceptable as long as the dose was given two weeks or more before the time of service).

Has documentation of a medical exemption.

Has proof of a recent (within the previous 72 hours) negative COVID-19 test (either PCR or Rapid Test). The test may not be from Alberta Health Services or Alberta Precision Laboratories.

Those under age 12 would not need to provide proof of immunization or a negative test to enter a participating business.

This program would not apply to businesses or entities that need to be accessed for daily living.

Albertans can access copies of their COVID-19 vaccination records through MyHealth Records. The printable card, which was going to be made available on Sept. 16, will now be available on Sept. 19.

Vaccines are the most powerful tool in the fight against COVID-19. Vaccine appointments are widely available through AHS or participating pharmacies and physician clinics. Book yours at alberta.ca/vaccine.

With harvest underway in Alberta, a reminder that a step to marketing is knowing the product that you have to offer

'Producers should be taking samples of each load as the crop is placed into storage to create a representative sample for each bin,' explains Neil Blue, provincial crop market analyst with Alberta Agriculture and Forestry.

'The goal is to have a sample that has the same characteristics as the large volume of product that it represents. Producers will then have a sample that can be used to shop around with various potential buyers.'

The samples should be stored in a sealed container to identify the source bin.

'This container should keep out rodents and

insects and preserve representative moisture content to maintain sample integrity. Some grain companies provide zip lock bags just for this purpose, which in turn, could be kept in a larger sealed container,' he adds.

One of the services of the Canadian Grain Commission (CGC) is the Harvest Sample Program.

'It gives producers a free, unofficial grade on samples from the current year's crop. Producers can submit samples of newly harvested crop prior to November 30 and obtain base grade information for their marketing at no charge. This program also helps the Canadian Grain Commission, the Canadian International Grains Institute, and grain buyers to better know, in a general way, the quality of the crop.'

Producers can learn more and sign up for the

Harvest Sample Program online, over the phone, or email. The Commission sends participating producers a personalized kit, including postage-paid envelopes for the samples. Producers fill the envelopes with representative crop samples and mail them to the CGC.

The Harvest Sample Program can be used for cereal grains, pulses, canola, flaxseed, mustard seed and soybeans. The grading report includes the following valuable information that a producer can use in crop marketing:

- unofficial grade for each sample submitted
- dockage assessment on canola
- protein content on barley, beans, chickpeas, lentils, oats, peas and wheat
- oil, protein and chlorophyll content for canola
- oil and protein content and iodine value for flaxseed
- oil and protein levels for mustard seed and soybeans
- falling number for wheat and rye
- vomitoxin (deoxynivalenol or DON) levels for wheat, corn and barley

'Individual reports remain confidential, but in collecting the grade information, the Commission can assemble and publish aggregated data on crop quality, useful to buyers and sellers,' says Blue. - *AgriNews*

Canada's Oil and Natural Gas Industry's Report on Emissions

The Canadian Association of Petroleum Producers (CAPP) released a report titled, Canada's Natural Gas and Oil Emissions: Ongoing Reductions, Demonstrable Improvement. The report, which lays out the means to a lower-carbon future through innovation and new technology and illustrates the industry's proven track record of lowering emissions-intensity, is the first in a series of planned Environment, Social and Governance (ESG) disclosures.

Highlights of the report:

From 2011 to 2019 combined natural gas, condensate and natural gas liquids production increased 32 per cent while emissions intensity in this sector decreased by 33 per cent.

As a result of Canada's flaring conservation practices, this country ranks among the lowest-emission natural gas producers globally.

While production from Oil Sands In Situ facilities grew by 66 per cent from 2013 to 2019, emissions intensity dropped by 8 per cent.

From 2013 to 2019 oil sands mining production increased 59 per cent as emissions intensity decreased by 14 per cent.

Canada's offshore industry produces some of the world's lowest emission oil.

The industry has a broad portfolio of innovative solutions to deliver emissions reductions; technological advances that are not just aspirational, but are making a difference now and continue to be developed to improve performance in the future.

Some examples of these technologies are discussed in the report and include:

Methane Reduction – Industry is working to reduce methane emissions to meet Canada's goal of a 45 per cent reduction from 2012 levels by 2025. Among the world's top 10 petroleum exporters, Canada alone has a methane reduction target. Industry is working with the Alberta government on the Alberta Methane Field Challenge which is testing new methane detection technologies including sensors on drones and trucks.

Carbon Capture, Utilization and Storage – Facilities are already showing how CO2 can be captured and stored or used in the production process, keeping millions of tonnes of CO2 out of the atmosphere.

Cogeneration – Upstream producers can use waste heat to generate electricity. In the oil sands, excess electricity not used for plant operations is sold to Alberta's power

grid. Cogeneration supplies about 34 per cent of the province's electricity

Supplying affordable, reliable and cleaner energy to a growing global population is the goal of Canada's upstream energy industry. Advancing greenhouse gas (GHG) emissions reduction is critical to realizing the vision for Canada to be a global supplier of choice with lower-carbon natural gas and oil.

Canada's Natural Gas and Oil Emissions: Ongoing Reductions, Demonstrable Improvement, is the first report in a planned series of ESG disclosures from CAPP members which is expected to include Indigenous Engagement; Diversity and Inclusion; Air, Land and Water; Research and Innovation as well as Process and Personal Safety.



Variable Speed Corridors: Between Yellowhead Highway and Hope you may encounter a few variable speed corridors during a road trip. Coal's other uses....

Cement

Cement is critical to the construction industry – mixed with water and gravel it forms concrete, a key construction material.

To produce cement, energy is required. Coal is an important source of the energy needed. A high-temperature kiln, often fuelled by coal, heats the raw materials of calcium carbonate (generally in the form of limestone), silica, iron oxide and alumina to a partial melt at 1450°C, transforming them chemically and physically into a substance known as clinker. This grey pebble-like material comprises special compounds that give cement its binding properties. Clinker is mixed with gypsum and ground to a fine powder to make cement.

Coal combustion products (CCPs), such as Fly Ash also play an important role in cement manufacture and in the construction industry generally.

Aluminium

Coal is a key energy fuel in the production of aluminium – a non-ferrous metal known for its lightweight properties and widely used in cars,

trains, and airplanes to reduce the weight of these vehicles and their energy consumption. Coal accounts for over 60% of the energy used to produce aluminium.

Transportation

Coal-derived fuels, as well as coal-based electricity, play a significant role in responding to the growing energy needs of the transport sector. Not only is coal an important raw material and source of primary energy for the manufacturing of materials used to build transport infrastructure, coal-based electricity has a role to play in supporting the electrification of the transport sector.

Liquid fuels from coal can provide a viable alternative to conventional oil products and can be used in the existing supply infrastructure. Several coal-to-liquids (CTL) demonstration plants are being developed in China, whilst in South Africa liquid fuels derived from coal provide 30% of South Africa's transport fuel requirements and CTL plants produce more than 160,000 barrels of liquid fuel per day from coal.

Hydrogen

Hydrogen is used daily as a gas and liquid by many industries, including the petroleum industry, transport and in manufacturing processes for producing chemicals, foods and electronics.

Coal gasification offers a versatile and clean method of converting coal into hydrogen and other valuable products. Gasification breaks down the

coal into its basic chemical components. In modern gasifiers, coal is typically exposed to steam and carefully controlled amounts of air or oxygen under high temperatures and pressures. Under these conditions, molecules in coal break apart, initiating chemical reactions that typically produce synthesis gas (syngas), hydrogen, carbon monoxide and other gaseous compounds. The hydrogen can then be captured and stored. 20% of hydrogen production comes from coal-to-gas processes.

Japan and Australia are pursuing hydrogen production strategies using lignite as the primary source product.

· Japan's 'Basic Hydrogen Strategy' plans to use lignite fuels that are decarbonised by gasification and catalytic conversion, providing hydrogen fuel.

· A proposed lignite gasification project in Australia would use the production of synthetic gas from burning coal under high pressure, then converting the carbon monoxide generated into carbon dioxide with steam and separating out the hydrogen. (WCA)

The Evergreens Foundation updates Town Council

Evergreens Foundation CAO Kristen Chambers presented Town Council with an update regarding the Foundation's Supportive Living Strategic Plan including the status of current and upcoming projects.

The Pine Valley Lodge in Hinton is set to begin welcoming residents during the weekend of September 18 and 19. The project is "on schedule and on budget" according to Chambers.

With the completion of both Parkland Lodge in Edson and the Pine Valley Lodge in Hinton the Foundation is setting its sights on the next two projects on their list: the Victor Lake Indigenous Elders Lodge in the Victor Lake Cooperative just outside of Grande Cache and the Wildwood Seniors Lodge in Wildwood.

The plans for the Victor Lake Indigenous Lodge call for a 12-unit supportive living facility intended to, "address the specific care and cultural requirements of the Indigenous population in the Grande Cache area." The lodge will bring additional services to the community and will be operated jointly with the Cooperative and the Evergreen's Foundation. \$2.25M from the province in grant funding for the projected \$7M project has been secured through the Indigenous Housing Capital Program.

Chamber told Town Council the project comes with infrastructure challenges due to its remote location as well as the lack of services within the community. The Foundation is meeting with the M.D. of Greenview to explore partnership opportunities. Chambers said, "This is an incredible win for the Indigenous Community in the M.D. of Greenview."

The Foundation will be looking at ways to synergize with the Whispering Pines Lodge in Grande Cache to ensure operational efficiencies.

The Wildwood Seniors Lodge is also moving forward. Chambers told Council that Yellowhead County has donated the land for the future facility. The plans for the Wildwood Seniors Lodge include a 45 bed facility, which would meet current demand, but include amenities to accommodate a further 25 beds in the future if needed. The cost of the project is anticipated to be \$17M.

The Evergreen's Foundation has secured \$225,000 from CMHC (the Canada Mortgage and Housing Corporation) to begin the initial studies and start the design process for the Wildwood facility. Chambers told Council that some of the geotechnical work as well as site investigation has been completed.

Chambers said there are pros and cons to building a lodge in a hamlet, but that seniors love the idea - especially those that lived in the county. The opening of a facility in Wildwood would create more spaces in Parkland Lodge as it is expected that county residents would desire relocating closer to the hamlet where they lived.

Mayor Zahara asked if there were any staffing concerns to which Chambers replied that she is not worried, "We attract incredible staff - it is a wonderful place to work."

Vaccinations are the safest and most effective way to protect communities from COVID-19's damaging effects. At Alberta's post-secondary institutions, vaccinations have proven to be a

These individuals should follow the self-declaration exemption procedures already in place at their post-secondary institution and will be reasonably accommodated.

Implementation dates and details for these new measures will vary from institution to institution according to their specific needs and policies.

It is an approach to health and safety that is best suited for the learning, studying, researching, working, and living environments of our campuses. 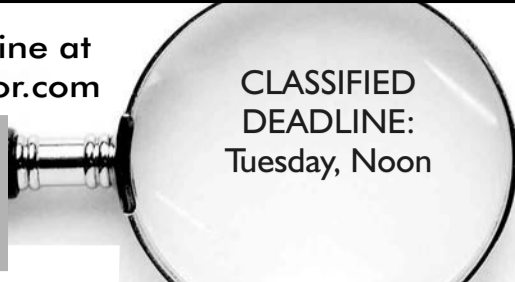
